DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

I responded to assist D/S J Francis #20627 with a crash involving a possible impaired driver. She advised me of the following: On 12/12/19 at approximately 0136 hours, I responded to the intersection of Santa Catalina and Purdy Ln in unincorporated West Palm Beach FL in reference to a single vehicle crash.

Upon arrival, I observed PBCFR personnel (Run #19132029) removing a white male from the driver seat of the black Ford F150 bearing FL tag 348RPH. The driver was then identified by FL DL as Francesco Badalamenti (W/M DOB 10/22/1971). When fire rescue asked Francesco if he had been using any drugs or alcohol, he advised that he had a few drinks that night and was just trying to get home. It should be noted that Francesco refused to be transported by PBCFR. The Ford F150 was on the side of the roadway and crashed into a metal fence and bushes. A passerby called 911 to report this crash. The caller stated there was a male passed out behind the wheel.

OBSERVATION OF DRIVER:

Upon my arrival the defendant was standing next to D/S J Francis's patrol vehicle. The defendant was leaning on her front bumper. I spoke with the defendant about the crash. His eyes were red and glassy. His pupils were constricted. His eyelids were drooping and he was on the nod. He was abnormally sweaty based on the current weather conditions. The defendant had an odor of an unknown alcoholic beverage on his breath.

DRIVER'S STATEMENTS:

He stated he drank 1.5- 2 beers at Duffys. He denied any illegal drug use. He said he was not injured and did not hit his head in the crash. He stated that an unknown female was driving. He could not provide me with any information about this female. He did not know how the crash occurred. He said we were on Cresthaven, but we were actually on Purdy Rd. He said he was traveling north, but Purdy runs east and west. He said he has a pre-existing leg injury as well as a birth defect of his legs, of which affects his balance.

The defendant had an odor of an unknown alcoholic beverage on his breath.

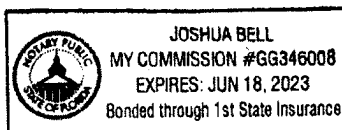

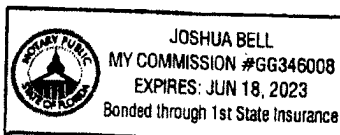
