


<p>Throughout the investigation, the defendant would randomly mention some other type of medical disorder or medication that she was taking. The defendant gave inconsistent responses to questions that I asked her more than once.</p> <p>I advised the defendant that I concluded my DUI investigation and, based on the observational clues on the SFST's and the strong odor of an unknown alcoholic beverage emanating from her breath, determined that she was too impaired to operate a motor vehicle and placed the defendant under arrest for DUI. The defendant verbally stated that she understood. I placed the defendant in handcuffs that were checked for proper fit and tightness and double locked and placed defendant in the rear of my PBSO marked patrol vehicle and transported the defendant to the B.A.T. (Breath Alcohol Testing) facility. Once at the B.A.T. the defendant was observed for a period of twenty minutes, during which time the defendant did not ingest anything, place anything in her mouth regurgitate or vomit. After the twenty minute observation period the defendant was placed on camera and asked if she would submit a breath sample for the purpose of determining its alcohol content and the defendant consented. The defendant provided two breath samples and the results were .154 for the first sample and .156 for the second sample. The results were given, and explained to the defendant and the defendant verbally stated that she understood. I read the defendant her Constitutional warnings on camera and the defendant verbally stated that she understood her rights. The defendant cooperated with Q&A.</p> <p>Based on the above set of facts and circumstances, probable cause exists to find the defendant in violation of FSS 316.193 (1) Driving while under the influence.</p> <p>I issued the defendant a citation for DUI and transported the defendant to the main detention center, without incident, for booking and processing.</p> <p>This case is cleared by arrest.</p>

D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 10/18/2016, at approximately 1812 hours, I responded to the intersection of Military Trail and Wenhart Road in Lake Worth, located in unincorporated Palm Beach County, Florida at the request of D/S Anthony Swigert #26679 to conduct a DUI investigation on a traffic stop. Upon arriving at scene I made contact with D/S Swigert who advised the following: "On the above date and time, I responded to the intersection of Hypoluxo Road and Military Trail reference a subject calling 911 regarding a possible impaired driver. Upon my arrival I observed a white Mercedes bearing Florida tag CKAX78 in the middle lane of Military Trail heading northbound. Once I was able to catch up to the vehicle at the intersection of Lantana Road and Military Trail, I observed the driver, later identified as Francine Chokanis, slouched in the driver's seat with her face pushed up against the steering wheel. I positioned my vehicle behind hers and observed Chokanis fail to stay in her lane. I then initiated the emergency lights on my fully marked patrol vehicle and pulled Chokanis over. I made contact with Chokanis and smelled an obvious odor of an unknown alcoholic beverage. At this point I requested a D.U.I. unit to respond to my location, D/S Chiquito ID#18334 responded to my location and took over the investigation".

OBSERVATION OF DRIVER:

When I arrived on scene I observed a white four door, older model Mercedes Benz, bearing Florida tag CKAX78, facing northbound on the westbound left turn lane at the intersection of Military Trail and Wenhart Road. I observed the driver and sole occupant of the vehicle, a female later identified as Francine Maria Chokanis (defendant) DOB: 11/11/1973 by her Florida driver's license, still sitting in the vehicle, behind the wheel and with her seatbelt on. I approached the vehicle and instructed her to exit the vehicle. I observed that her hair was disheveled and her lipstick and eye make-up was smeared. I also observed a wet, chunky substance in her hair, on her forehead and on her cheek. I could smell a strong odor of an unknown alcoholic beverage emanating from the defendant's person and from within the vehicle. Prior to exiting the vehicle the defendant fumbled to remove her seatbelt and braced the door frame as she stumbled out. I relocated the defendant to the front of my patrol vehicle and with my in car video and audio system activated, I advised her that I was conducting a DUI investigation to determine if she was too impaired to operated a motor vehicle. She verbally stated that she understood. I read the defendant her Constitutional warning from a PBSO issued pre-printed Miranda card and the defendant verbally stated that she understood her rights as I read them to her. The defendant was very fidgety and talked excessively and kept repeating herself. As the defendant spoke with me the odor of alcohol emanating from her breath became stronger.

DRIVER'S STATEMENTS:

Post Miranda the defendant stated that she was on her way home from work at the City of Boca Raton City Hall and that she did not consume any alcohol. The defendant further stated that she just found out today that she is pregnant and would not be "drinking". When asked about any medical conditions or medication use, the defendant stated that she suffered from a traumatic brain injury in 2013, has epilepsy and has difficulty with her balance at times. She currently takes Floxetine twice daily and Ambien as needed. I asked the defendant if she would submit to voluntary SFST's and she verbally consented. I used a yellow pre-painted line on the roadway where the surface was flat, dry and free of debris and away from through traffic. SEE Probable Cause PAGE 2 for further.....

ODORS:

Strong odor of an unknown alcoholic beverage emanating from defendant's breath that became stronger as the defendant spoke to me

GENERAL OBSERVATIONS

SPEECH: Slow, slurred, mumbled, excessive talking

ATTITUDE: Mood swings, argumentative, repeated herself,

CLOTHING: Blue/Green patterned dress, green eye glasses, black wedge heels

MEDICAL/OTHER: Defendant stated she had traumatic brain injury in 2013 and epilepsy/seizures. She takes Floxetine twice a day and Ambien as needed.

Glassy, red eyes. Unsteady gait. Disheveled hair and clothing

WALK & TURN:

Instructed and demonstrated. Defendant verbally stated she understood the instructions. The defendant started task before being instructed to do so. Had to be repositioned while explaining task. The defendant took nine nine steps forward placing one foot in front of the other but not touching heel to toe. After step #9 she pivoted on the balls of her feet and completed an improper turn. She then crisscrossed/overlapped her feet, stumbled and lost her balance and just stood there with her arms crossed at her back. After approximately 20 seconds without any movement I asked if she was done and she replied "yes" and the task was ended.

ONE LEG STAND:

Instructed and demonstrated. Defendant verbally stated she understood the instructions. The defendant had to be repositioned and did not maintain the instructional stance. She began the task before being instructed. She held her arms out more than six inches, with her elbows bent, hands spread open and facing forward. She began the task with her knee bent for the first few counts, then straightened her leg and pointed her toes upward. She looked straight ahead during the entire task and she dropped her foot and lost her balance at count #1008.

FINGER TO NOSE:

Instructed and demonstrated. Defendant verbally stated she understood the instructions. The defendant demonstrated proficiency with identifying her left from her right hand. I repeatedly instructed her to maintain her head tilted back and her eyes closed. I observed her swaying back and forth and she rocked from the balls of her feet to her heels to assist with her balance. On instruction #1 she placed the pad of her finger flat (vertical) on the septum of her nose. On command #2 she touched the side of her nose, readjusted and touched her septum. Command #3 she placed the pad of her index finger on top of her nose and all her fingers were spread open and at one point she rested the remaining fingers on her face/cheeks. Commands #4 and #5 she pressed her nose down using the pad of her finger. Command six she placed her middle and index finger on the top of her nose. She had to be instructed every time to return her hand down to her side.

ROMBERG ALPHABET:

Instructed and demonstrated.. Defendant verbally stated she understood the instructions. Immediately after hearing the instructions, when instructed to begin the task, the defendant separated her feet and clenched the sides of her dress with her fists to assist with her balance. Once I instructed her to place her feet together I observed her swaying back and forth and she rocked from the balls of her feet to her heels to assist with her balance. She recited the alphabet in a fast pace. I repeatedly instructed her to maintain her head tilted back and her eyes closed.


