ACCORDING TO THE CALLER (COMPLAINANT) THE DRIVER OF ANOTHER CAR BEGAN TAILGATING, FLASHING HIS LIGHTS AT HER AND ONCE HE GOT AROUND HER BREAK CHECKING HER. THIS STARTED IN BROWARD COUNTY AT INTERSTATE 75 AND US 27. AS THEY BOTH HEADED NORTH BOUND THE ROAD RAGE ACTS CONTINUED BY THE DEFENDANT NOW IDENTIFIED AS FRANCISCO LEON 8-30-64. THE VICTIM NOW IDENTIFIED AS CHANTAVIA JACKSON 2-5-1986 CALLED POLICE, SHE SAID SHE STARTED WITH BROWARD OR MIAMI-DADE THEN BROWARD BUT JUST AS SHE TOLD THEM THEY PASSED THE SIGN THE READS "PALM BEACH COUNTY" THEY TRANSFERRED HER TO PBSO. SHE EXPLAINED THE DEFENDANT WAS ATTEMPTING TO RUN HER OFF THE ROAD SEVERAL TIMES AND THROWING ITEMS AT HER CAR. AT SOME POINT HE SLOWED DOWN AND TOOK A BOTTLE OF WATER AND THREW IT OUT THE PASSENGER SIDE OF HIS VEHICLE INTO THE OPEN WINDOW OF HER CAR (DRIVER SIDE) AND ACCORDING TO THE VICTIM HITTING HER IN THE FACE "THROWING A DEADLY MISSILE". THE BOTTLE LANDED ON THE FLOOR BOARD OF HER CAR WHILE SHE FOLLOWED HIM INTO THE LAKE OKEECHOBEE CONSTRUCTION SITE (UP ON THE LEVEE) IN SOUTH BAY AS SHE WAS ON THE PHONE WITH POLICE. THE VICTIM WAS ON THE PHONE WITH POLICE FROM THE TIME THE INCIDENT TOOK PLACE UNTIL I ARRIVED ON THE LEVEE. THE DEFENDANT NEVER CALL POLICE WHEN HE SAID SHE WAS WAVING A MACHETE AT HIM HE NEVER CALLED. IT SHOULD BE NOTED THE VICTIM TOLD THE PBSO DISPATCHER SHE HAD A KNIFE / MACHETE IN HER POSSESSION FOR PROTECTION. AS I BEGAN MY INVESTIGATION I SPOKE TO THE DEFENDANT AND GET HIS IDENTIFICATION, WHEN HE OPENED THE DOOR OF HIS VEHICLE TO STEP OUT I NOTICED SEVERAL BOTTLES OF "SILVER SPRINGS" WATER, THE LABEL IS PRINTED IN AQUA BLUE AND PINK I THEN SPOKE TO THE VICTIM WHO TOLD ME HER SIDE OF THE INCIDENT AND EVEN POINTED OUT THE BOTTLE OF WATER LYING ON THE FLOORBOARD OF THE PASSENGER SIDE OF HER VEHICLE. THE BOTTLE WAS THE SAME AS WHAT'S IN THE DEFENDANTS VEHICLE. AFTER TALKING WITH THE VICTIM I WENT BACK TO THE DEFENDANT AND ON IN-CAR-VIDEO READ HIM HIS MIRANDA WARNING AND ASKED HIM TO TELL ME WHAT HAPPENED AND I POINTED OUT THE MATCHING BOTTLE OF WATER FOUND IN THE VICTIM'S CAR. 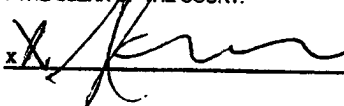
