On the 4 day of June, 2018 at 20:21 (Specifically include facts constituting cause for arrest)

On Monday, June 04th, 2018, I responded to 146 E. Blue Heron Boulevard in reference to a disturbance between a white male and female. Upon arrival, contact was made with the two subjects, later identified as Freddie Michels (08/12/1965) and his alleged wife, Kristin L. Swain (04/08/1967) both sitting on the curb apparently intoxicated. Swain was crying and visibly upset while Michels appeared to be dazed confused. Both were very clearly intoxicated and uncooperative upon my initial approach.


Both Swain and Michels were brought to their feet and were observed having a difficulties standing up. The smell of alcohol was very prominent from both Swain and Michels. There were minor cuts on Michels, who stated that he fell down while arguing with Swain. Swain, was uncooperative and exaggerating an argument in the presence of the Officers on scene drawing in a bigger crowd of spectators from the Inlet Bar and Liquor store.

After the two were separated, Officers made contact with employees at Inlet Bar, who stated that two were patrons at the bar and began having a verbal dispute. Once Swain and Michels left the bar, the dispute escalated and continued near the road way on E. Blue Heron Boulevard just in front of the businesses curb entrance. Although there were no cooperating witnesses, employees from the Inlet Bar Liquor Store stated that they heard loud arguing and saw Swain very animated and verbally attacking Michels. Swain, in her drunkenness was the aggressor in the exchange which lead to them both falling to the pavement where I met them.

Medics were denied on scene by both Swain and Michels, who also both denied that a physical dispute had taken place.

Swain and Michels were arrested and transported to Riviera Beach Police Department booking.

As a result of my investigation both Kristin L. Swain and Freddie Michels were charged with disorderly intoxication and separately transported Palm Beach County Jail.
