

I made contact with the caller W/F Sandrine Aubert.</p> <p>Aubert stated that she is a co-owner of the Boca's Breakfast Club with her husband W/M Frederic Dannenmayer. She stated that yesterday, 01/17/17 at 0710 hours she got in a verbal argument with her husband outside of the restaurant. Dannenmayer was very agitated at her over decisions she made regarding the business. She stated that he began grabbing all the produce that he bought for the business from inside his car and began throwing it all on the ground. Aubert explained that she tried to get in between him and the car, attempting to calm him down by holding her hands up to him. When she stepped in between her and the car he grabbed her with a very tight grip around both her arms and pushed her out of his way. She stated that when he finished throwing all the produce on the ground he left in his car. She explained that two days prior to that they were arguing in the kitchen of the restaurant when he was so frustrated, he pushed her. Aubert was concerned that he was becoming more aggressive and he might get worse but she did not want to get him in trouble. She showed me pictures of her bruises on her arms that she took yesterday and I observed the bruises on her arms.</p> <p>I made contact with Dannenmayer at his residence, 350 SE Mizner Blvd. Apt 1405. Dannenmayer admitted that he did grab Aubert to move her out of the way when he was angry and wanted to finish throwing all the produce out of his car yesterday morning. He stated that he was mad at her because she wasn't managing the business in the same way he agrees with. He also admitted to pushing her during an argument that happened two days prior.</p> <p>Aubert was not cooperative and photos could not be taken of her bruises.</p>
