NARRATIVE: I am part of a National Task Force known as the South Florida Internet Crimes Against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

On 6/15/17, I located Internet Protocol (IP) address 73.49.15.190 in a database maintained by law enforcement and utilized by federal and state law enforcement agencies in child exploitation investigations, nationwide. This database maintains a log of IP addresses that have been previously involved in the possession and distribution of videos/images involving the sexual conduct of a child. Files are automatically compared to a known set of hash values as contained in the database that have been identified as the sexual conduct of a child from previous investigations by other law enforcement officers. A hash value is a mathematical function which is used to produce a unique digital signature of a file. The data acquired, including hash value, IP address, name of the file, date and time it was identified by the database provided from the suspect computer, are all logged.

A query done on the database for Palm Beach County, Florida, revealed IP Address 73.49.15.190 was logged for sharing digital movie files on the Gnutella Network on dates ranging from 1/3/17 through 6/15/17, that were believed to be child pornographic files. I was able to view several video files that were the same files having been seen from IP address 73.49.15.190, based upon the same hash value, such as:

[REDACTED] (12Yo) 2 Of 4.avi. This video file depicts a nude prepubescent (approx. 8-10 yoa) girl lying on her back, with her legs spread apart. An adult male is first seen digitally penetrating the girl's vagina while performing oral sex on her. The video then cuts to the girl performing oral sex on the male.

2) Video File Name: [REDACTED]
[REDACTED] - Part 1 0608 4m41S.mpg. This video file depicts a prepubescent Asian girl performing

oral sex on an adult male. The male then vaginally penetrated the girl with his penis and ejaculates on her vagina.

On 6/15/17, I requested the Palm Beach County State Attorney's Office issue a subpoena to Comcast for IP Address 73.49.15.190. I requested the subscriber information and IP logs, which specifically corresponded to the dates and times that this IP was seen as having been available for sharing the files listed, being 5/31/17 at 12:29 GMT; 6/8/17 at 08:23 GMT; and 6/12/17 at 07:58 GMT. The dates and times corresponded to the dates/times in which the IP was seen as having been available for sharing files. Comcast responded to the subpoena advising IP address 73.49.15.190 was assigned to subscriber Elizabeth Harrison, 15510 Meadow Wood Drive, West Palm Beach, FL 33414, Telephone # 561-793-5880.



On 10/5/17, a second subpoena was issued to Comcast requesting the subscriber information and IP logs for the dates of 6/10/17 at 17:19 GMT and 6/11/17 at 04:54 GMT, for IP address 73.49.15.190. The dates reflect 2 more dates in which the IP was seen as having been available for sharing files that were not listed in the subpoena served to Comcast on 6/15/17. Comcast responded to the subpoena advising IP address 73.49.15.190 was assigned to Elizabeth Harrison, 15510 Meadow Wood Drive, West Palm Beach, FL 33414, Telephone # 561-793-5880.

On 10/24/17, I appeared in front of Honorable Judge Glenn Kelley and obtained a search warrant for the residence of 15510 Meadow Wood Drive, West Palm Beach, FL 33414.

On 11/1/17, the search warrant was executed at 15510 Meadow Wood Drive, West Palm Beach, FL 33414, and contact was made with Gabriel Harrison. Post Miranda Gabriel Harrison admitted to viewing and downloading child pornography since college, on a frequent basis, using his desktop computer. He further advised he would save the child pornographic videos and images in designated files on the desktop, such as a file titled "stuff".

An on scene preview of Gabriel's desktop computer revealed numerous video and image files involving the sexual conduct of children. While on scene I viewed 20 video files which involved different prepubescent children engaging in sexual activity with adults.

Based on my investigation and evidence gathered Gabriel Harrison was placed under arrest and booked into the Main Adult Detention Center on 20 counts of Possession of the Sexual Performance by a Child, contrary to F.S.S. 827.071(5) and 1 count of Computer Child Exploitation 847.0135(2).
