


<p>On 10-20-16, I was assigned a theft from a gas station at 1255 W. Palmetto Park Rd, which was originally reported to Ofc. McNichol. The following is a summary of the initial report:</p> <p>At 1257 hours on 10-10-16, Ofc. McNichol responded to the Valero Gas station, located at 1255 W Palmetto Park Road, Boca Raton for a theft where he met with Mona Getman who stated that she is an employee of Hershey Chocolate. She was inside the Valero Gas Station, adjusting a product display when she placed the company iPad valued at \$1500.00, bearing serial #DLXLVOZ5FLML, on the counter under the credit card keypad, while she moved a display. Getman explained that at 1220 hours on 10-10-16, she discovered that her iPad was missing from the counter.. Getman and store manager Bruce Swanwick reviewed the surveillance video which revealed that at 1213 hours on 10-10-16, a w/f with dark hair, and a dark top, is seen swiping her credit card, after purchasing cigarettes. Getman stated that the female is seen holding the iPad as she turned and walked away from the counter. Swanwick stated that the female comes in to the station on a regular basis. On 10-19-16, Det. Derstein responded to 1255 W Palmetto Park Rd (Valero) in reference to retrieving video evidence for a credit card fraud that occurred inside the store. The DVR system was a GESS analog DVR. It should be noted that the DVR time during the retrieval was 10-19-16 at 1254 hours and the real time according to Det. Derstein's watch was 10-19-16 at 1302 hours indicating the DVR was 8 minutes behind. Upon reviewing the video, he observed the white female in question on the surveillance video at the register. The video during the time frame of the incident is backed up on a USB thumb drive and was placed on to a CD-R. The CD-R was labeled and submitted into evidence per our department standards.</p> <p>On 10-14-16 at 1310 hours, Ofc. Kresse spoke with Mona on the telephone. Mona advised the possible subject returned to the Valero in a 2007 Grey Mitsubishi bearing FL tag #DFEL19. Mona requested that I add this to her original report for further</p>

<p>investigation.</p> <p>On 10-20-16, I called and spoke to Swanwick. He explained that Mona had gotten the tag and name of the suspect from the cashier who recognized the suspect who had come into the store again. The cashier wrote down the vehicle information and looked at the ID of the suspect when she made her purchase. The tag was registered to Gabriella Correa, DOB 10-15-92.</p> <p>I called Getman and she said she could ID the girl that stole the ipad. She described the girl as having tattoos and the suspect was right next to her on video. I obtained and watched the video of the suspect, who had a large "hello kitty" tattoo in the middle of her chest, swipe the ipad and place it under her phone as she was paying at the register.</p> <p>On 10-20-16, I met with the clerk at the gas station and she was shown a photo line up with Correa's picture. She was unable to identify. She was the employee who saw the suspect come back to the store, interacted with her, and got the vehicle information and saw the suspects ID at the store.</p> <p>On 10-21-16, I met with Getman who was shown a different photo line up with Correa's picture and she was able to ID Correa as the girl who stole her ipad.</p> <p>On 10-31-16, Det Lamia and I drove around the plaza where the gas station was and checked all parking lots based on the statement from the gas station employees that the suspect went into the business "all the time." Upon checking, a gray Mitsubishi convertible with the FL tag DFEL19 was located in the parking garage. Upon checking the businesses inside, we located Correa in suite #428 at 1489 W. Palmetto Park Rd. Upon speaking to her, I showed her the still photos from the video at the gas station and she identified herself. She explained she took the ipad, left, then realized what she had done and left the ipad on the ground in the area of the gas station. She offered to pay for the ipad. She was cooperative and was placed under arrest.</p> <p>Based on the positive photo ID by the victim, the matching tattoo on the Correa's chest seen on video (and in person), and based her statements about the incident, Gabriella Correa is suspected of violating FSS 812.014(2c1)-Grand Theft (over \$300). She was processed and transported to County Jail.</p>
