On Wednesday April 12, 2017 at approximately 1937 hours, I responded to 1181 Summit Place Cir Unit D, within unincorporated West Palm Beach, FL in reference to a Domestic Battery. Prior to my arrival PBSO dispatch received a call from a Jeffery Lopez, who advised that his ex-girlfriend hit him and left in a tan Nissan.

Upon my arrival I met with Lopez who stated that his ex-girlfriend, a Gabriela Enrique Diaz(defendant) came to his residence in an attempt to have him sign papers. Lopez stated that the defendant has been trying to have him sign documentation to allow his son to travel to Nicaragua. Lopez has refused and advised that he does not feel comfortable letting her travel outside of the country with his sons. The defendant took a bag of Lopez and threw it on his vehicle. Lopez took the bag and put it in his patio, when he returned back to his vehicle he noticed that the defendant was going through his wallet. As Lopez approached the defendant she took flight with his ID. Lopez went after her and retried his ID, in doing so the defendant scratched Lopez on his neck and left forearm. The defendant then left the scene in her Tan Nissan.

Lopez suffered a small laceration on his to his forearm, and multiple abrasions to his forearm and the back of his neck. Deputy Cisson ID: 24091 arrived on scene and took pictures of the victim's injuries. See his supplement for further information.

Based on the above facts I believe Probable Cause exists to charge Gabriela Enrique Diaz with Simple Battery(Domestic Related) contrary to F.S.S. 784.03(1a1).
