

I instructed Reed to keep her hands by her side, stand with her feet together, and follow a red light stimulus with her eyes not turning her head. I asked her if she understood my instructions. Reed verbally stated she understood my instructions. I observed both eyes to be red, bloodshot, and glossy. Her left and right eye displayed equal pupil size, equal tracking, and a lack of smooth pursuit. I observed distinct and sustained nystagmus was present in both her left and right eye at maximum deviation during two separate four second evaluations. The onset of nystagmus was prior to a 45 degree angle in both her left and right eye during two separate four second evaluations.</b></p>					
	<p><b>WALK AND TURN - I positioned Reed on a white line which was on a smooth and level surface, free of any debris and well lit by the headlights on my vehicle and nearby street lighting. ## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Thursday, April 19, 2018 at approximately 0451hrs, I was dispatched to 19298 Pennell Pines Road in unincorporated Boynton Beach, County of Palm Beach, Florida 33436 in reference to a traffic crash. Upon my arrival, I made contact with Joseph Corra who advised he witnessed a black Ford SUV hit a stop sign, hit a tree then hit a mailbox before coming to a stop. Fire Rescue Truck # 244 (RUN# 18043191) was on scene tending to a female, later identified as Gabrielle Reed by her West Virginia DL. I asked Reed where she was coming from and she said Boca Raton. I asked Reed if she had anything to drink and she responded with 4 Rieslings. Once Fire Rescue cleared Reed, I proceeded to begin a DUI investigation.

## OBSERVATION OF DRIVER:

I observed Reed to walk down the street towards my marked PBSO vehicle, wearing a white blouse with a floral pattern, blue jeans and brown sandals. Reed provided a West Virginia DL, which was her only form of identification. I observed Reed's eyes appeared red and glassy. I observed that she was slurring her words and was emitting a strong odor of an unknown alcoholic beverage from her breath. Reed was asked to perform field sobriety tasks which she agreed to.

## DRIVER'S STATEMENTS:

I asked Reed if she had been drinking or used any drugs and she stated that she had 2 drinks of Riesling (wine), tequila and a mojito. I asked Reed if she has any medical problems and/or previous injuries and she said she suffered from seizures. I asked Reed if she wears glasses or contacts to correct his vision and she answered "yes". Finally I asked if Reed was on any medications and she said she should be taking them for her seizures but doesn't.

## ODORS:

Obvious odor of an unknown alcoholic beverage
