

On November 24th, 2017 at 1244 hours, I responded to 1059 Winding Rose Way, West Palm Beach, FL 33415 a subdivision of Victoria Woods in unincorporated Palm Beach County in reference to an Aggravated Battery incident. Upon my arrival I spoke with the victim Walter Deshommes who stated that he was delivering a washing machine and the home owner Gary Millar threw a cordless drill in his direction and the drill struck him the head. Mr Deshommes stated that he is a delivery driver for Brandsmart and was delivering and installing a washing machine inside Mr Millar's residence. Mr Deshommes stated that he went upstairs to remove the old washing machine from the laundry closet and noticed that the washer power cord had 4 prongs and that Mr Millar had ordered the 3 prong power cord with the washing machine to be installed which would not work unless the old power cord was installed on the new washing machine. An argument broke out between Mr Millar and Mr Deshommes as he was explaining the details about the washing machine cord. Mr Millar was physically holding the garage door open to allow Mr Deshommes to dolly the washing machine into the residence through the garage door. Mr Deshommes handed his dewalt cordless drill to Mr Millar and said "take this upstairs". Mr Millar felt that Mr Deshommes was being aggressive with him and Mr Millar threw the cordless drill toward the driveway in front of the garage. The drill struck Mr Deshommes in the forehead causing a small 1.5 inch abrasion on Mr Deshommes forehead. PBC Fire Rescue tended to Mr Deshommes wounds on scene under run #17126547.

Mr Millar stated that he didn't intend to strike Mr Deshommes with the drill, but did admit to throwing the drill. DS Vessage 8493 took photos of the scene and obtained sworn written statements from Mr Deshommes, Mrs. Yzis Quintero (Mr Millar's wife), and Mr Louis Joseph (Bransmart delivery driver).

Mr Gary Miller is in violation of F.S.S. 884.041(1) Felony Battery.
