

D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN:

While sitting stationary at the intersection of Alternate A1A and Old Dixie Highway, I observed a black Chevrolet SUV traveling north on Alternate A1A at a high rate of speed. The SUV then made a fast turn onto Old Dixie Highway traveling north. I caught up to the vehicle and got behind at a red light at the intersection of Old Dixie Hwy and Tequesta Dr. Once the light turned green, the vehicle accelerated quickly to approximately 45MPH in a 40MPH zone. The SUV was weaving and crossed the center double yellow line with both left side tires then the right white solid line with both right tires. The vehicle then continued weaving within it's lane, then again crossed the right white line with both right side tires this time putting both right side tires onto the grass. The driver over corrected and when he steered left, both left side tires crossed the center double yellow line. The driver then turned left onto County Line Rd and finally right onto SE Suddard Dr. at which point I activated my emergency lights and siren. The driver came to a stop momentarily, then continued driving. I activated my siren again and the vehicle came to a stop at the intersection of SE Suddard Dr. and SE William Terrace.

OBSERVATION OF DRIVER:

Upon approaching the vehicle I immediately smelled the strong odor of an unidentified alcoholic beverage. I also noticed his eyes were bloodshot and watery. I requested the driver's documents and he fumbled through the center console pulling out multiple receipts and items. He then dropped all off the papers onto the floor and retrieved his driver's license from his wallet and handed it to me. He then picked up some of the papers and located an insurance card which he gave me. He stated that he could not find his registration. Upon stepping out of the vehicle, he was unsteady on his feet. When I had him stand in front of my patrol vehicle, I noticed he was using my push bumper for balance.

DRIVER'S STATEMENTS:

I asked him if he was having any medical issues or if his truck had any mechanical issues. He stated his front left tire was low and that he was not having any medical issues. I asked if he had anything to drink, he said no. I asked where he was coming from, he said "Can I give it some thought and let you know?" When I said I would prefer that he just tell me the truth, he said "I would prefer not to".

Strong odor of an unidentified alcoholic beverage emanating from his breath.






