On 02/07/18, at approximately 0040 hours, while patrolling S Federal HWY at approximately the 1000 block, I observed a gold in color vehicle bearing FL TAG JKBZ64, with no functional tag light.

I initiated a traffic stop for the violation of F.S.S 316.221 (2) no visible tag light. The vehicle came to a stop in front of 814 S Federal Hwy. I Approached the vehicle and made contact with the driver identified as, Gary Rosenbaum. I asked Rosenbaum if there was there any weapons or drugs inside the vehicle. Rosebaum spontaneously utter he had some "crack cocaine" inside his pack of cigarettes. Rosenbaum stated the crack was located inside the a small plastic bag within the pack of cigarette. Rosenbaum willfully handed me the pack were I located approximately 3 small white in color small rocks. Due to my experience and training I recognized them to be crack cocaine rocks. The total package weight of the bag containing the cocaine was approximately 1.2 grams.

I field tested the white in color rocks using department issued testers of both cobalt and Duquoeis testers, which yielded positive results for cocaine. Rosenbaum was taken into custody for the violation of F.S.S 893.13(6a), possession of cocaine. Rosenbaum was placed into handcuffs, doubled locked, and checked for proper fit. Rosebaum was also issued a uniform traffic citation # A812FUE for violation of F.S.S 316.221 (2), no working tag light.

Rosebaum was transported to the Main Detention Center, without further incident.

This case is cleared by an arrest.
