<p>[REDACTED] was one of the 'decoys' posing as a prostitute in the 3600 Block of S. Military Trail Greenacres, FL 33463.</p>										
<p>[REDACTED] was approached by a W/M later identified as Gene R. Stephens D.O.B. 3-16-36, who was driving a four door Lexus bearing Ohio tag FFY 1025. Upon Stephens contact with [REDACTED], Stephens asked her if she was working. [REDACTED] stated that she was. Stephens asked [REDACTED] how much for a hand job. [REDACTED] stated that it would be twenty dollars. Stephens stated that would be OK but he wanted [REDACTED] to his apartment. [REDACTED] stated that she did not want to go to his apartment and directed Stephens to the rear of the gas station.</p>										
<p>The predetermined signal was given and the arrest team responded from a concealed location, stopped the Stephens and took him into custody without incident. Stephens was placed in zip cuffs that were checked for fit and was transported to 4639 Lake Worth Rd. Greenacres, FL (Mil Lake Plaza) [REDACTED] where he was turned over to Corrections Deputies for processing and later transported to the Palm Beach County Jail.</p>										
<p>Stephens requested his vehicle be parked at 3479 S. Military Trail. (IBERIA BAR AND GRILLE)</p>
