### Probable Cause

On June 9, 2018 I was on routine patrol in Palm Beach County in my marked patrol car. I arrived on the scene of a traffic stop that was on I-95 (State Road 9). Trooper J. Vega stated that he was traveling northbound on I-95 (State Road 9) north of Yamato Road. He stated that he observed a grey colored Porsche traveling northbound at a high rate of speed and passing cars on the left and right. He stated that he obtained a vehicle pace of 94 mph in a 65 mph zone. He then observed the vehicle change lanes aggressively and fail to maintain a single lane. He then stated that he activated his emergency lights and sirens to initiate a traffic stop on the vehicle. He then approached the vehicle and stated that as he talked to the driver

he observed that the driver had bloodshot glassy eyes and the odor of an unknown alcoholic beverage was emitting from his breath as he talked. I then arrived on scene and took over the investigation. I approached the passenger side of the vehicle and introduced myself to the driver. I observed that he had bloodshot glassy eyes, slurred speech and the odor of an unknown alcoholic beverage was emitting from his breath as he talked. The driver was later identified as Geoffrey Batsiyan by his FL DL. I then requested that he walk towards my patrol car. As he stood in front of me I observed the odor of an unknown alcoholic beverage, blood shot glassy eyes, slurred speech and an orbital sway. I then requested that he preform field sobriety exercises and he refused. I then stated to him the consequences of refusing the roadside exercises and that it can be used against him in court. He then refused again. He was then placed into handcuffs and under arrest for DUI. I then requested Mr. Batsiyan open his mouth so that I check and begin a 20-minute observation. He refused to open his mouth and was attempting to swallowing something inside of his mouth. I requested multiple times that he open his mouth and he refused. He was ultimately secured inside of my patrol car and transported to the Palm Beach County Jail. Once I arrived at the county jail I checked his mouth and began a 20-minute observation. At no time did he take anything by mouth or regurgitate. I then requested that he provide a lawful sample of his breath and he refused. Implied consent was read and he stated that he understood. He refused again to provide a sample. He as then booked into the Palm Beach County Jail.

Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
