On Tuesday, March 22, 2016, I, Deputy Morrison ID# 25007, was dispatched to 1774 Sawgrass Cir, Greenacres, FL 33413, in reference to a report of a domestic battery. Upon my arrival, I met with the victim, W/F [REDACTED] DOB 8/31/80, who stated that she was a victim of a battery on the previous night. [REDACTED] mentioned that her boyfriend, whom she resides with as a married couple, broke her ribs. Hearing this, I obtained a sworn audio recorded statement of the incident.

While speaking to [REDACTED], she informed me that her and [REDACTED] went to dinner with her boyfriend, W/M George A. Fahmy 10/4/78, on the evening of Monday March 2, 2016. During dinner, she mentioned that Mr. Fahmy was drinking heavily. Upon leaving the restaurant, Mr. Fahmy became very emotional and began punching the vehicle's dashboard and slapping himself. [REDACTED] mentioned that she became concerned, because she has known Mr. Fahmy for nearly 20yrs and had never seen him act like this. When they arrived at their apartment complex, Mr. Fahmy lit a cigarette as he walked up the stairs to their residence. As [REDACTED] opened the door to the residence, she asked Mr. Fahmy to put out the cigarette. It was at this time, Mr. Fahmy grabbed her by the face with his hand. He then pushed her into the residence. The force of this push to the face caused [REDACTED] to stumble backward and fall over a couch, landing in an awkward position. [REDACTED] stated that she injured her neck and back during this incident. Mr. Fahmy then jumped on top of her, holding her down with his knee on her chest. [REDACTED] mentioned that as she tried to get up and get away from Mr. Fahmy, he held her down against her will with his knee [REDACTED] chest. [REDACTED] mentioned that [REDACTED] observed this incident as they both begged Mr. Fahmy to stop. Mr. Fahmy continued to restrain [REDACTED] who then yelled for [REDACTED] to dial 911. Hearing this, Mr. Fahmy stood up and stopped with his actions. [REDACTED] mentioned that [REDACTED] froze at this time and did not call 911 as ordered. [REDACTED] mentioned that she was short of breath but stood up while Mr. Fahmy gathered a bag of belongings to leave the residence.

Once Mr. Fahmy had his items together, he again approached [REDACTED] as they stood face to face. He then picked her up by the arms and threw her onto the ottoman. [REDACTED] mentioned that she heard a heard a snap as her upper torso landed on the metal portion of the ottoman. Mr. Fahmy then jumped back on top of [REDACTED] who was lying [REDACTED] back. He placed his knee into her chest and then placed his forearm across her neck. Due to the knee to her chest [REDACTED] mentioned that it was

difficult to breath. (It should be mentioned that although Ms. Fahmy placed his forearm across [REDACTED]'s neck, this action did not prevent her from breathing or restrict the circulation of blood.) [REDACTED] mentioned that she screamed again for [REDACTED] to dial 911. Hearing this, Mr. Fahmy stood up, grabbed his bag and then fled the residence.

[REDACTED] mentioned that she later arrived at Wellington Regional Medical Center to be treated for her injuries. X-rays were taken of [REDACTED]'s chest and hairline fractures were discovered to her second and third ribs located on the left side of her torso. [REDACTED] mentioned that the location of the broken ribs is where she landed on the ottoman when Mr. Fahmy threw her and the source of the snapping sound she heard were her ribs breaking.

After obtaining a sworn audio recorded statement from [REDACTED], I took pictures of her injuries. A diagonal bruise was seen to her upper torso and about a two inch in diameter circular bruise was seen to the upper left hip area. [REDACTED] mentioned that there were additional bruising to her mid to lower hip area. Due to the location of the mentioned bruising, I did not attempt to take any pictures. I did inquire about a copy of the X-rays but [REDACTED] informed me that she did not have copies at this time.

After speaking to [REDACTED], I then conducted a audio recorded taped interview of [REDACTED]. This interview was conducted inside a bedroom where we were the only two people present. During this interview, I determined that Lucas was of sound mind and had a good understanding of what took place. During the interview Lucas mentioned that Mr. Fahmy had drank beer and wine while out to dinner. While on the way home, Mr. Fahmy was upset. Once they arrived home, Lucas mentioned that his mother flipped a cigarette out of Mr. Fahmy's hand as they entered their residence. Lucas mentioned that he then saw Mr. Fahmy punching and slapping his mother on the back, neck, and stomach area. Lucas stated that he saw the mentioned incident from the beginning to the end and was afraid that Mr. Fahmy was trying to kill his mother.

After the completion of both statements, I obtained Mr. Fahmy personal information from [REDACTED]. I called Mr. Fahmy reference this case. I asked Mr. Fahmy what took place of the night of this incident. Mr. Fahmy stated that he took [REDACTED] and Lucas to dinner. When he went to use the restroom, [REDACTED] ordered an alcoholic beverage. Mr. Fahmy mentioned that [REDACTED] should not be drinking due to the type of psychological medications she's prescribed. Mr. Fahmy mentioned that after she drank alcohol with the combination of the pills, she "flipped out." He stated that she argued with him the entire ride back to the residence. Upon returning home, Mr. Fahmy mentioned that [REDACTED] attacked him for no reason and that all he did was defend himself from getting hurt. Mr. Fahmy stated that he sustained bruises to his head from this incident and that once things calmed down, he grabbed a bag and left the residence.

I asked Mr. Fahmy if he could arrive at Palm Beach Sheriff's Office District 16 so that I could take pictures of his injuries. Mr. Fahmy was hesitant and then responded that he was currently in New York. I did provide Mr. Fahmy my e-mail address. As of the time of this report, I had not received any pictures showing any injuries to Mr. Fahmy.

Due to the findings of my investigation, I do believe that probable cause does exist for the arrest of Mr. Fahmy for Aggravated Domestic Battery and False Imprisonment.

[REDACTED] was provided a Victim's Rights pamphlet and a Domestic Rights form. I discussed the services which are provided to victims of domestic battery to include seeking a shelter. [REDACTED] informed me that she did not need a shelter since she was currently staying with her parents due to this incident.
