On the **9** day of **March**, **2018** at **02:23** (Specifically include facts constituting cause for arrest.)

On 03/09/2018 Ofc Codling and I responded to 610 NW 13th Street Unit # 25 (Oaks of Boca) in reference to a domestic disturbance.

Upon arrival Ofc Graham had W/M George Beuchert (DOB 11/08/2018) seated outside of his residence. Beuchert appeared to be highly intoxicated and having a hard time keeping his stories straight as to what had transpired. Beuchert stated, he and his live-in boyfriend of six months, W/M Sage Hornsby (DOB 10/31/2018), got into a verbal argument that lead to Beuchert "kicking" Hornsby out of their apartment. According to Beuchert, he and Hornsby were enjoying a night of drinking and Netflix when Hornsby fell asleep. Beuchert explained, that when Hornsby awoke he was in a rage over not having any more alcohol to drink. Beuchert was unclear how the fight started but recalled fighting off Hornsby by trying to choke him which is when Hornsby grabbed Beuchert by his triceps in an attempt to prevent him from choking him. Beuchert explained, Hornsby has been abusive in the past and he was "tired of it" so he refused to let him get the best of him this time. Beuchert explained, that Hornsby at one point during the altercation grabbed a scuba knife with a red handle and slashed a wine box in his rage. Ofc Codling and I conducted a search of the apartment producing negative results for a knife or cut wine box described by Beuchert. Beuchert stated the altercation ended when he forced Hornsby out of their apartment and called BRPD. Beuchert stated, Hornsby keep banging on their front door until BRPD arrived.

The apartment had a broke plate on the living room floor and the entire apartment appeared to be in disarray. The kitchen had an empty vodka bottle and there were two more empty bottles located in the master bedroom. The west side of the bed had vomit from someone that had recently eaten bowtie pasta.

While conducting my investigation Ofc Graham spotted Hornsby trying to return to the rear of the residence. Upon seeing Ofc Graham, Hornsby fled on foot west bound and was
