DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Loudaros was observed by officers operating his vehicle. Loudaros explained his vehicle ran out of gas as he was traveling eastbound on PGA Blvd on the top of the fly over bridge. Loudaros stated he put his vehicle into neutral his friend got out of his vehicle and pushed his vehicle backwards. Loudaros steered the vehicle as it traveled backwards down the PGA Blvd fly over, into the Shell Gas Station, through the bushes, and back out onto PGA Blvd. Loudaros was then stopped by the officers.

OBSERVATION OF DRIVER:

Loudaros had red, glassy, bloodshot eyes, slurred and mumbled speech, a strong odor of an unknown alcoholic beverage emitting from his breath, and was unsteady on his feet.

DRIVER'S STATEMENTS:

Loudaros stated he was coming from City Place in West Palm Beach and had consumed alcohol earlier in the night.

Strong odor of an unknown alcoholic beverage emitting from his breath

Other Observations:

Loudaros had a hard time keeping his head still while following the stimulus.

WALK & TURN:

While explaining the instructions, Loudaros lost his balance several times and had to go back to the starting position with his right foot in front of his left. Loudaros began the task and fell off the line on his first, fourth, sixth, fourteenth, eighteenth, nineteenth, twentieth, twenty third, and twenty sixth steps. Loudaros did not count aloud as instructed. When Loudaros got to the twenty sixth step, I asked him if he remembered the instructions. Loudaros explained the instructions of nine steps forward and nine steps back. Loudaros asked if he could attempt the task again. I had Loudaros go back to the starting position and explained the instructions again. Loudaros had a hard time remaining in the starting position with his right foot in front of his left. Loudaros began the task again and fell off the line on his sixth, seventh, eighth, and eighth again. Loudaros took ten steps and did not turn around as instructed. Loudaros began walking back and fell off the line on his fourth step. Loudaros did count aloud as instructed.

ONE LEG STAND:

Loudaros began this task with his right foot. Loudaros lifted his foot more than six inches off the ground, lost his balance, and immediately put it back to the ground. Loudaros lifted his right foot again, more than six inches off of the ground, stated he was ready, and began swaying back and forth. Loudaros lost his balance and placed his foot back to the ground at approximately seven one thousand. Loudaros was not counting aloud as instructed. I asked Loudaros if he remembered the instructions. Loudaros stated he did and repeated the instructions to me. Loudaros began with his right foot, lifting it higher than six inches, used his arms for balance, and put his foot back down at one thousand six. Loudaros lifted his right foot higher than six inches, and counted to 10.

FINGER TO NOSE:

On left, Loudaros touched the right side of his nose, corrected to the tip of his nose, and left his finger there until asked about the instructions. On left, Loudaros touched the right side of his nose and corrected back to the tip. On right, Loudaros touched his left cheek and corrected to the tip. On left, Loudaros touched under his right eye and corrected to the tip. On right, Loudaros used the middle of his finger to touch the tip. On left, Loudaros missed his nose and corrected to the bridge of his nose. On left, Loudaros touched the bridge of his nose. On right, Loudaros touched between his eyebrows.
