<p>In the City of Riviera Beach, Palm Beach County Florida, the following incident occurred;</p> <p>On Tuesday, January 24th, 2017, at approximately 5:59pm, Officers of the Riviera Beach Police Department responded to 4216 Leo Lane Apt. B1 in reference to a domestic disturbance. Riviera Beach Police Communications received a call from the alleged victim's daughter Makenzie Johnson who was not on scene stating that her mother Laura Lee Rister (W/F 11/21/1971) was being physically assaulted by her step-father Gerald J. Bess (W/M 07/11/1971), who may have possibly broken her mother's arm. Upon arrival, Officer D. Edwards #6261 observed an unknown white male and unknown white female walking southbound in front of the apartments. Officer Edwards made contact with the male identified above, who stated he was drinking and an argument ensued between him and his fiancé which later resulted in him pushing her to the ground. Officer Edwards then made contact with Rister who stated the incident began after Bess picked her up from coaching a soft ball practice and she noticed that he was drinking. Rister stated they drove from Palm Beach Lakes High School to their residence where Bess became more aggressive.</p> <p>Rister stated she removed her soft ball cleats and Bess stood directly in front of her whilst they were in the bedroom and would not allow her to exit the room. According to Rister, Bess stated to her that she valued soft ball more than their relationship and then proceeded to push her. As a result, Rister fell backwards and her left arm struck the post on the bed causing a small abrasion to her elbow area. . It should be noted, Rister denied medical attention and stated that her arm was not broken. Bess then exited the residence after the incident. Bess and Rister do not share any children in common, have never been married, and have been</p>
