<p>On 01/15/2017, at approximately 0300 hours I responded to a vehicle crash on the East Indiantown Road Bridge located at 500 East Indiantown Road in the Town of Jupiter, Palm Beach County, Florida. I was driving a marked Jupiter Police vehicle. PFC Borrows was in the passenger seat. We were both wearing full Jupiter Police Uniforms with outer vests marked with the word "POLICE". We had standard uniform shirts with Jupiter Police patches visible and were visibly armed with full duty belts.</p> <p>The vehicle was silver Mustang bearing Florida tag Y65SCW. Upon my arrival I observed the vehicle had severe front end damage. It was facing west in the eastbound lanes. The vehicle appeared to be unoccupied. I then saw a male on the west bound side of the bridge, directly across from where I had parked my vehicle. The male, later identified to me as the registered owner of the Mustang, Giampiero Collu, was staggering around and having a very difficult time standing up. There was no one else in the area.</p> <p>I drove my vehicle to the other side of the bridge and made contact with Collu. Collu appeared to be extremely intoxicated and was using the rails on the bridge to hold his balance. I made sure Collu was not injured from possibly being in a crash. When I spoke to Collu his speech was very slurred and difficult to understand. There was a very strong presence of an unknown alcoholic beverage emitting from Collu. The bridge is approximately 100 feet over the intra-coastal waterway and Collu was in a narrow space between traffic barriers and the barriers for the bridge. Fearing for his safety, PFC Borrows and I asked him to move with us to a safer open area about 30 feet to the east. PFC Borrows began to escort Collu to the safer location, by holding his arm and giving verbal direction. Collu immediately fell down and began to yell incoherently. Collu, who displayed several dramatic mood swings during my contact with him, calmed down a moment later and agreed to be moved to the safer location. Collu put both his arms up in order to be escorted. PFC Borrows and I then escorted Collu to the location, with each of us holding an arm to help Collu maintain his balance.</p>



Collu sat down on the ground and I stood by with him while we attempted to identify Collu. I was standing to Collu's left. Collu suddenly began yelling belligerently and yelled "fuck you!" Collu swung his left arm towards me and struck my left leg, I bent over at the waist in an attempt to get control of Collu, who then struck me in my left arm with his left arm. Collu then aggressively used his left knee to strike my left thigh. I then directed Collu down onto his right side to facilitate prone handcuffing. PFC Borrows assisted me with handcuffing Collu. I secured Collu in handcuffs, which I checked for spacing and double locked. PFC Borrows then requested that Palm Beach County Fire Rescue respond to the scene. I had Collu sit up. He complied, but remained belligerent and argumentative.

Collu was transported to the Jupiter Medical Center for medical clearance by Palm Beach County Fire Rescue (Run 17-5640). Officer Yochum stood by with Collu while I completed my paperwork. After being cleared, Collu was transported to the Palm Beach County Jail, where he was charged with the following offenses per Florida State Statute: Resisting Arrest with Violence per FSS 843.01, and Battery on a Police Officer per FSS 784.07(2)(B).
