

Bremser observed a suspicious vehicle parked in the parking lot of 3199 N Federal Hwy. Ofc Bremser approached the vehicle and observed a W/F, later identified by her FL as Gina Rosesong, slouched over behind the wheel of her 2010 blue Suzuki SX4 bearing FL tag HMSZ68. The vehicle was parked at an angle inside of the parking lot facing southeast. The vehicle had its break lights and headlights on. Upon contact Ofc. Bremser knocked multiple times on the driver side window to get Rosesong's attention. After multiple attempts, Ofc. Bremser contact Boca Raton Fire Rescue to analyze Rosesong's medical condition. There was vomit on the exterior of the vehicle and on the ground outside of the driver door. Ofc. Bremser then placed his BRPD unmarked vehicle with his lights activated behind the vehicle.</p> <p>After multiple attempts at knocking, Rosesong finally awoke and Ofc. Bremser advised that he is a Boca Raton Police Officer and ordered her to place her vehicle into park. He then continued to identify himself and order her to place her vehicle into park. She then placed her vehicle into reverse and proceeded to strike Ofc. Bremser's vehicle with the lights activated. Ofc. Bremser reached in and turned the vehicle off. He then stood by until other BRPD units arrived. See Ofc. Bremser's supplement for further information.</p> <p>Ofc. Saavedra arrived on scene and conducted the accident investigation. See his accident report for further information.</p> <p>Upon my arrival, I observed Rosesong sitting in the driver seat with her seat belt on. There was vomit on the exterior and interior of the vehicle. I stood by while Ofc. Saavedra conducted the accident investigation.</p>



After the accident investigation was completed, Rosesong was asked to exit the vehicle and step in front of my marked BRPD unit 168. Rosesong was informed that the accident investigation was completed and I would be conducting a criminal DUI investigation. I read Rosesong her constitutional warnings from a preprinted BRPD card. She advised that she understood her rights and wished to speak to me. She advised that she was coming from a bar named "The Biscuit", which is located in Mizner Park, where she had a couple drinks with friends. She stated that she was travelling southbound towards Hillsboro Blvd to eventually travel home in Fort Lauderdale. It should be noted that 3198 N Federal Hwy is north of Mizner Park. She stated that she noticed that she should not be driving so she pulled over to rest until she felt fine to drive. She was unaware of where in Boca Raton she had stopped. She advised that she started drinking at 2030 hours and only had 2 beers until 2330 hours when she stopped drinking. She was unaware of Ofc. Bremser knocking on the door and unaware of being involved in any accident. Rosesong then advised that she would attempt the Standardized Field Sobriety Tasks to dispel my alarm of her driving under the influence. She advised that she did not have any illnesses or injuries that would prevent her from completing the tasks. It should be noted that while speaking with me, Rosesong had bloodshot and glassy eyes and swayed front to back. She also had the odor of an alcoholic beverage emanating from her breath.

The first task administered was the Horizontal Gaze Nystagmus. While performing the task, Rosesong moved her head and had trouble focusing on the tip of the pen. I observed the lack of smooth pursuit in both directions and in both eyes. I observed the onset of Nystagmus prior to 45 degrees in both directions and in both eyes. I observed distinct and sustained Nystagmus at maximum deviation in both eyes and in both directions. It should be noted that during the task, Rosesong swayed front to back and had glassy and bloodshot eyes along with the odor of an alcoholic beverage emanating from her breath.

The second task administered was the Walk and Turn. While Rosesong was placed in the starting position as I read the directions, Rosesong had trouble maintaining the starting position. She lost her balance multiple times. Rosesong stated that she understood the directions. Rosesong started before I advised her to start on multiple occasions. While performing the task, Rosesong did not touch heel to toe and used her arms for balance. She stepped off the line multiple times. She stopped after the first 9 steps and did not start again until I told her to return back taking 9 steps.

The third task administered was the One Leg Stand. Rosesong advised that she understood the directions. She raised her left leg off of the ground. She used her arms for balance and swayed. She dropped her foot multiple times to the ground. She then proceeded to put her left leg behind her and raise it off the ground. She stopped the task at approximately 22 seconds. She stated she understood the directions multiple

times but did not complete the task as asked.

The fourth task administered was the Finger to Nose. I demonstrated the task and Rosesong advised that she understood the directions. The test was administered in the pattern of L-L-R-L-R-R-L. During each direction, she had trouble maintaining the starting position. She did not touch his nose with the tip of his finger. She did not return his finger to his side. While in the starting position, Rosesong swayed front to back.

The fifth task administered was the Rhomberg Alphabet. Rosesong stated that she knew the English Alphabet. She recited the alphabet in a rhythmic tone during the whole task. She was able to complete the Alphabet correctly. During the task, she swayed front to back.

Based upon my investigation, Gina Rosesong was placed under arrest for DUI, a violation of FSS 316.193(1). Rosesong was taken to Boca Raton Police Department Holding Facility where she provided 2 breath samples of .101 and .102. Rosesong's car was removed by Westway towing. Rosesong was medically cleared at Boca Raton Regional Hospital and eventually turned over to Palm Beach County Jail.


