On Sunday, July 22, 2018 at approximately 2302 hours, I responded to the Chevron gas station located in the village of Royal Palm Beach, Palm Beach County, Florida in reference to a assault type incident.

Upon my arrival, I met with a white male, Sean R. Kirtz, 2/12/1985, who advised that he just left the Rascal Flats concert at the Sky Vodka theatre with his ex-girlfriend (Gina T. Parasimo) and kids (Sean K. Kirtz Jr. and Leo J. Kirtz) when a verbal dispute later turned physical altercation took place between himself and Gina. He further stated that Gina had multiple drinks at the concert and once they left the concert in his blue BMW bearing FL tag SLJ83 , she started to argue with him over their difference. Sean further stated that the verbal dispute ensued into a physical altercation and Gina started to hit him while he was driving. He further stated that he pulled into the Chevron gas station in efforts to minimize any the physical altercation from taking place in his vehicle in front of their kids in common. Sean advised that when he pulled over, he walked around to the passenger side of the vehicle, opened the vehicle door and requested Gina to exit the vehicle. Another physical altercation took place with both parties as Sean stated that Gina kicked him on the face as he attempted to assist Gina out of the car. Sean advised that he was defending himself against Gina and wanting to prevent any further physical altercation from taking place. After concluding my investigation, I met with Sean Jr (son) who briefly advised that an argument took place between his father and his daughter's ex-girlfriend (Gina) and stated that Gina started the arguing. He further stated that Gina hit his dad multiple times while arguing in the car. After concluding my investigation with Sean Jr., I met with the original complainant, Joseph M. Alasia, white male, 11/01/1993 who advised that he was at the gas station getting air for his tires on his vehicle when he heard a loud verbal dispute take place between a male and female, which later turned into a physical altercation. Joseph stated that he saw the white male (Sean) attempting to calm down white female (Gina) as she kicked him multiple times.

After concluding my investigation, I determined that Gina T. Parasimo, white female, 3/10/1986 to be the primary aggressor and in directly violation of FSS 784.03(1)(A)(1), Simple Battery Domestic Related.
