

On the <u>8</u> day of <u>July</u> , <u>2017</u> at <u>01:53</u> (Specifically include facts constituting cause for arrest.)												
<p>On 7/8/2017 at approximately 1:04am I was dispatched to 4000 RCA Blvd (Marriott) Palm Beach Gardens, Palm Beach County, FL 33410 in reference to a hit and run involving two vehicles. Prior to my arrival, my body worn camera was activated.</p> <p>Upon arrival, I made contact with the victim Kenneth James. James advised his vehicle was parked on the far Northwest corner of the Marriott parking lot. James stated he was conducting traffic enforcement in the parking lot when he observed a dark colored SUV reverse and crash into his vehicle then drive away from the scene. James's vehicle sustained damage to the rear left side bumper and quarter panel. James observed a white female later identified as Ginger Kress seated in the driver's seat of the vehicle and advised she was the sole occupant. James attempted to tell the female to stop but she continued to drive her vehicle southbound in the parking lot. James could not read the tag on the vehicle due to the excessive speed by the vehicle.</p> <p>At approximately 1:13am, North Palm Beach Officers located the suspect vehicle with significant damage to the rear of the vehicle at the intersection of Macarthur Blvd and Northlake Blvd. North Palm Beach Officers conducted a traffic stop at the intersection of Macarthur Blvd and Northlake Blvd and identified the driver as Ginger Kress.</p> <p>I advised James that Officers have located the vehicle and asked if he would be able to identify the driver and the vehicle. James stated "yes I would". I transported James to the scene of the traffic stop and conducted a show up. James positively identified Kress as the driver and the vehicle that crashed into his parked vehicle. Upon approach to the vehicle, I observed significant damage to the right side rear bumper and quarter panel of the suspect vehicle. I also observed fresh paint marks from the victim's vehicle on the suspect vehicle. The location of the damage correlates with the statement provided by James.</p>



<p>James provided a sworn statement via body worn camera and advised he wishes to prosecute. James was issued a crash report with a case number.</p> <p>A witness, Delene Peart also observed the crash and was able to identify the vehicle and driver. Peart provided a sworn witness statement via body worn camera.</p> <p>Based on my investigation, Kress was arrested pursuant to F.S.S. 316.063(1) Leaving Scene of an accident or failed to leave info (unattended property damage) and F.S.S. 843.02 Resisting without violence.</p> <p>During the course of the arrest, Kress attempted to escape from her handcuffs and climb out of Officer Barkers marked patrol vehicle (See Ofc Barkers Supplement). A charge of Resisting without violence was added based on Kress's actions.</p> <p>Kress was placed in handcuffs which were checked for proper spacing and double locked. Kress was issued two citations for leaving the scene of an accident and no insurance on the vehicle.</p>
