The defendant requested a cab from east coast taxi service and was picked up by the victim Xeres Delva at Porta Bella Italian, Boynton beach, fl. around 9am this morning. Xeres was requested to drive to numerous locations through out the day by Giovanni until 4:30pm when he attempted to be dropped off. When Xeres requested the 200.00 fair for his services Giovanni said, he had to call someone that he didn't have any money. All attempts by Giovanni to secure the fair money was unsuccessful. Xeres allowed Giovanni to exhaust all avenues to secure the money prior to calling the Sheriffs office.

Additionally Xeres gave Giovanni 100 dollars through out the day. Giovanni said, he would pay him back. when I asked Giovanni he said he used the money to buy drugs and has no money.

Based on my investigation, what I observed and what was said to me I found the defendant Giovanni M Latronica in violation of FSS 817.52(2) Obtaining vehicles with intent to defraud, hiring with intent to defraud by hiring a vehicle for transit services with out paying for the services rendered.

Giovanni was later transported to county jail.
