

I was informed by the homeowner Christina Monserrate that her ex-boy friend who came to be known as Giovelle Rosa Jr. arrived at her residence uninvited and intoxicated causing a disturbance. According to Monserrate, at approximately 0015 hours, she was awoken by a pounding on her front door and the sounds of her door bell ringing multiple times. She stated that she looked outside from her bedroom window and observed Rosa Jr. standing in her driveway. It should be noted that Rosa Jr. is Monserrate's former boyfriend and he used to live at her residence between September 2016- July 2017. The two ended their relationship and he moved out of the residence in July 2017.

According to Monserrate, Rosa Jr. does not have any keys to her residence and he does not have any remaining belongings at her residence and she no longer communicates with him.

Monserrate stated that as she was walking out of her bedroom and towards the front door of her residence she heard Rosa Jr. scream and yell numerous times "who is here?" and continued to pound on the front door. Rosa Jr. then proceeded to pound on the glass panels on the front door and subsequently broke the glass while he was beating on it. As a result of his actions, it caused the glass to shatter throughout both the inside and outside of the residence.

Monserrate stated that she immediately contacted BRPD 911 dispatch because she was scared and concern for her safety.

It should be noted that when officers arrived on scene Rosa Jr. had a laceration to his

right hand as a result of glass getting stuck in his hands. He was bleeding and subsequently transported to Boca Raton Regional Hospital for additional medical treatment by Boca Raton Fire Department.

Monserate stated that she believed that Rosa Jr. thought she had "another person" in her house which caused him to get so angry that he broke the door while he was pounding on it.

It should be noted that I observed shattered glass throughout both the inside and outside of the residence. There was also a broken glass panel on the front door and blood in the immediate vicinity belonging to Rosa Jr. Pictures of the scene were taken and submitted into BRPD evidence.

Monserate stated that the glass panels as well as the amount that it would cost to repair the front door was \$500.00. She stated that she did want Rosa Jr. to be prosecuted for breaking the glass panels on her front door. Monserate completed a written statement form which was subsequently submitted into BRPD evidence.

Officer Reissi stood by with Rosa Jr. as he was getting medically treatment at Boca Raton Regional Hospital for his laceration.

I then spoke to Rosa Jr. to get his account of the incident. I read Giovelle Rosa Jr. his Constitutional Warnings from an agency issued Miranda Card. He stated that he was just going to see Monserate and talk to her because she was not picking up her phone. He first stated that he "opened the door and the glass broke" and then stated "no, he went to the door, and the glass just broke".

It should be noted that both Rosa Jr. and Monserate stated that at no time was there a physical altercation between the two.

Giovelle Rosa Jr. was placed into handcuffs and placed under arrested at 0115 hours. Handcuffs were checked for tightness and double-locked.

Giovelle Rosa is being charged with Criminal Mischief pursuant to F.S.S 806.13(1B)2 for willfully and maliciously damaging property valued at \$500.00 belonging to another individual. He was then transported to Palm Beach County Jail.
