 On the 7 day of January, 2018 at 16:46 (Specifically include facts constituting cause for arrest.)

On Sunday 1/7/2018 at approximately 1503 hours, I responded to 5700 W. Glades Road (Macys) in reference to a shoplifting investigation.

Upon arrival, I made contact with Macys LPO Marie Bros. Marie advised that she observed a W/F later to be known as Girlena Herrera, walking around the store carrying several shirts folded in her arm. She stated that Herrera took a white shirt off a hanger and continued walking around the store and into the handbag department where she went behind a register and took several white plastic shopping bags from behind the counter. After this she concealed all the shirts in the white shopping bag. Herrera then took a black handbag and a pair of Beats Headphones and conceal them in the white shopping bag. As she continued to walk around the store she entered the cosmetic/fragrance department and concealed several boxes of perfumes and cosmetics in her own purse. Then she goes upstairs to the second floor and selects a blue dress and black pants from the Juniors Department and walks into the fitting room. Several minutes later she exits the fitting room and neither item of clothing is visible. Herrera takes the escalator down to the first floor where she walks towards the Glades Road store exit, passing all points of sale and making no attempt to purchase any of the items. Bros and LPO Rispoli announced themselves both physically and verbally. Herrera was then escorted back to the office where all the merchandise was recovered. The total value of all the items taken is \$883.93. Bros advised she maintained a constant visual of Herrera. She completed a sworn written statement that was submitted into evidence.

I then made contact with Herrera and advised her of her Miranda Warnings in the presence of Ofc. T. Codling. She stated that she understood her rights and wished to speak with me. She said that she made a mistake and tried to take all the aforementioned merchandise without attempting to pay for it.
