On the **17TH** day of **APRIL** 20**18** at **0300** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On 04/17/2018 at approximately 0130 hours, I responded to, 9428 Fox Trot Ln in unincorporated Boca Raton, Palm Beach County, Florida in reference to domestic battery. PBSO dispatch advised they could hear a loud disturbance in the back ground while on the phone.

Upon my arrival, I met with the complainant/victim, identified by Florida DL as Quang Vo. The victim explained that after returning from work at approximately 0110 hours his wife and mother of his two children, later identified by Florida DL as, Glenda Hurtado (the defendant) cornered in the home office and began a verbal altercation. The altercation turned into a physical incident and Glenda began to punch Quang with a closed fist in the chest, face, and grabbed his neck and pushed him. Even after Quang contacted 911 Glenda chased him from the office to the living room into the couple's bedroom. I observed several fresh red marks to the victim's chest and he had redness around the front of his neck. The victim also had a small laceration to his lip.

I attempted to interview the defendant about this incident, but she invoked her Marand Rights.

The home office within the residence showed signs of the incident. Items that would be commonly found on a desk were found on the floor within the room. A lamp was lying on the floor broken and in the hallway leading out of the office was several household items that were knocked over.

The victim completed a written sworn statement and DART photos of the victim and scene were taken and uploaded to the DART website.

Based upon my investigation the defendant did actually and intentionally touch and strike the victim against his will and did intentionally cause bodily harm to the victim, contrary to Florida Statute 784.03(1). (1 DEGMISD)
