On 2/19/17 at 0123 hours, I responded to 3900 Jog Rd (St. Andrews School) in reference to a theft of a golf cart and trespassing. Upon my arrival I made contact with St. Andrews School security guard W/M Joseph McCullough, who advised that he observed 4 W/M's on a school golf cart on school property by the baseball field. McCullough advised that he observed a W/M, later identified by Florida DL as John Driscoll, riding on the golf cart with 3 other W/M's. McCullough advised that Driscoll jumped off the golf cart and stayed with McCullough until our arrival.

I placed Driscoll in handcuffs and read him his Constitutional Warnings from a preprinted card. Driscoll advised that he understood his rights and wished to speak with me. Driscoll advised that he was riding on the back of the golf cart for 15 seconds before he was confronted by security and admitted to jumping the fence from a friend's house to come on the property.

McCullough drove me on his golf cart to the area where the stolen golf cart was ditched by the suspects by the baseball field. I observed three subjects, later identified by Florida DL's as W/M/J [REDACTED], W/M Christian Smith, and W/M Grant Arnoff, riding on the golf cart. I observed [REDACTED] on the golf cart shirtless and wearing light colored shorts. I observed Arnoff wearing a grey t-shirt and khaki pants. I was unable to determine their respective positions on the golf cart. The subjects were on the golf cart heading eastbound along the south property fence line of the school. I shined my flashlight on them and was able to observe the aforementioned clothing and physical descriptions. After a 40 yard pursuit in a golf cart, all three subjects fled from the golf cart and jumped over a 6 foot fence into the backyard of 2753 NW 34th St. I yelled at them "stop police" and they continued over the fence. I scaled the fence and then heard the sounds of a door closing in the backyard. I made contact with the owner of the house, W/F Candice Bernstein, who initially advised that only her son, W/M Jake Bernstein, and her younger son was home. Candice refused to allow us to search the

Residence and woke up her husband, W/M Eliot Bernstein, who eventually had Smith, Arnoff, Tristen Chianese-Brady, Vicent Sessa, and Jacob Noah-Archie exit the residence.

I read everyone with the exception of [REDACTED] their Constitutional Rights from a preprinted card. Everyone advised that they understood their rights and wished to speak with me. I spoke with Arnoff who advised that he was with Smith, Driscoll, and [REDACTED] on the golf cart. He advised that Smith, Driscoll, and [REDACTED] took turns driving the golf cart. Arnoff advised that he drove it around the grass fields on the school campus. Arnoff admitted to fleeing the property when he saw a flashlight and jumping the fence to Bernstein's house.

Grant identified [REDACTED] as the last subject that was at large and Grant called [REDACTED] cell phone. [REDACTED], who was about a block west of the house, answered his cell phone. [REDACTED] returned to the house and was read his Constitutional Rights by Officer Alvino from a preprinted card. [REDACTED] advised that he understood his rights and agreed to speak with us. [REDACTED] advised that he was a passenger on the golf cart, did not drive it, and jumped the fence when I pursued them. Smith admitted to being on the property but said he wasn't on the golf cart.

Bernstein, Chianese-Brady, Sessa, and Noah-Archie all advised that they were playing video games and did not enter the school grounds. Juvenile referrals were completed on Bernstein, Chianese-Brady, Sessa, and Noah-Archie and they were released on scene to their guardians.

I spoke with Director of Security for St. Andrews School, Anthony Hamilton, who advised that the school would prosecute for the theft of the golf cart and trespassing on school property.

Based upon my investigation, I placed Driscoll, Smith, [REDACTED], and Arnoff under arrest for Grand Theft pursuant to F.S.S. 812.014(1) and Trespassing on school property pursuant to F.S.S. 810.097(1A).

BRPD K9 and Detective Lamia and Rucco responded to the scene (see their supplements for further). The golf cart (a 2001 green Yamaha G16A 2 seat golf cart with St. Andrews golf cart #216 which was an estimated \$2,000 value) was towed to the police department for processing.
