Driver (later identified by Florida DL D142281552100) was southbound on S A1A in the 3000 block located in Jupiter (Palm Beach County) Florida. 

ONE LEG STAND: raised his leg 1-2 feet off the ground after being told and shown approximately 6 inches. Every time he raised his leg he put it back down, moved off the line onto pavement & failed at completing.

On several of the finger to nose DuPilko would repeatedly hold his finger on his nose and not lower his hand back to his side until being told to. 2ND Finger to nose went to bridge of nose.


