On 10/29/2017 at approximately 0030 hours, Officer Bissoon and I responded to 2911 Clint Moore Rd in reference to an assist another department.

I met with Officer Ryan White who advised me that a white male later identified as Gregory Nikolopoulos was passed out behind the wheel of a Rolls Royce bearing Ontario tag CAXX732 in the McDonald's restaurant drive-through located at the aforementioned address. Ofc. White also informed me that he could smell a strong odor of an alcoholic beverage coming from Nikolopoulos' mouth. Ofc. White also explained to me that initially it was implied that Nikolopoulos has suffered a heart attack behind the wheel, however, BRFD Paramedic Jason Sekula advised that Nikolopoulos was examined and it was determined that he had no medical need.

I then made contact with Nikolopoulos and asked him if he was okay. He stated yes and informed me that he went to a few local bars with friends. I asked him how much he had to drink and he stated "oh, about 7 or 8 beers". While conversing with Nikolopoulos, I could smell a strong odor of an alcoholic beverage coming from his mouth. His speech was heavy and slurred and I observed his eyes to be bloodshot, glassy, and red. I then asked Nikolopoulos to perform voluntary Standardized Field Sobriety Exercises (SFSE's) so I could ensure he was not intoxicated and would be ok to drive and he consented. The lighting consisted of my patrol vehicle, streetlights, and parking lot lights. The temperature was approximately 74 degrees. No surface defects were noted or claimed. Due to inclement weather, the exercises were conducted underneath the breezeway located at 2901 Clint Moore Rd directly behind the McDonald's restaurant.

The first FSE I asked him to perform was the Horizontal Gaze Nystagmus. I instructed him on where to stand and how to perform the exercise. I asked him if he had any head injuries past or present and he stated no. He was wearing a hat, which I instructed him to take off. He was not wearing glasses or any contact lenses. He did not have resting

nystagmus, and his pupil size was equal. He had lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and the onset of nystagmus prior to 45 degrees. Vertical gaze nystagmus was not present in either eye. While conducting the HGN, I continued to smell an odor of an alcoholic beverage coming from his mouth.

The second exercise was the walk and turn. I gave the instructions and demonstrated the exercise prior to asking him to perform it. I asked him if he had any physical issues that would prevent him from performing the exercise, and he stated that he has a bad left knee and pointed to his left leg. He failed to stay in the starting position as I was explaining the instructions. He could not keep his balance while listening to the instructions and was unable to stay in the starting position. On the first nine heel to toe steps, He stepped off of the line on steps 3,5 and 8. He did not perform the turn around properly. On the returning nine heel to toe steps, he stepped off the line on steps 6 and 7.

The third exercise was the one leg stand. I gave the instructions and demonstrated the exercise prior to asking him to perform it. I asked him if he had any physical issues that would prevent him from performing the exercise, and he stated that he has a bad left knee. I instructed him to begin whenever he was ready. He raised his arms six inches away from his body to assist with balance and dropped his foot on count 1004, 1005, 1007 and 1012. He failed to elevate his foot six inches from the ground. He also failed to look at his elevated foot while counting and exhibited a side-to-side sway during the exercise.

The fourth FSE I asked him to perform was the Rhomberg with Recitation. I gave the instructions and demonstrated the exercise prior to asking him to perform it. I asked him if he understood the instructions and he stated yes. I asked him if he knew the English alphabet and he stated yes. He started the exercise before instructions were given to begin. During recitation, he sang the alphabet and did not recite it in a slow rhythmic manner as instructed.

The fifth FSE I asked him to perform was the Finger to Nose exercise (L-R-L-R-L-L-R). I gave the instructions and demonstrated the exercise prior to asking him to perform it. I asked him if he understood the instructions and he stated yes. He failed to touch finger to nose on every turn. He also opened his eyes to locate his finger and exhibited a front to back sway during the exercise.

Based on the totality of circumstances, I placed Nikolopoulos under arrest for violation of F.S.S 316.193(1) at 0104 hours. I placed him in the right rear seat of my patrol vehicle.

Ofc Reissi responded to BRPD as my Breath Test Operator. Ofc Reissi and I conducted the 20-minute observation and then he was taken into the BAT room. Nikolopoulos was asked to provide a breath sample and he consented, however, he was requesting to speak with a


