PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was on routine patrol in the area of Parkside Drive and Donald Ross Road. I was stopped on Parkside Drive at the intersection with Donald Ross Road. There was a 2004 Toyota bearing Florida License Plate JA848Q stopped in the right turn lane directly in front of me. The driver of the vehicle, later identified to me as Guillermo Naranjoarambula, exited the driver's side door. Naranjoarambula then put the key in the lock. I exited my vehicle to make contact with Naranjoarambula. I noticed immediately that Naranjoarambula was unsteady on his feet and taking extra steps to keep his balance. Naranjoarambula stated he was having an issue with his vehicle's alarm going off. Based on my observations of Naranjoarambula (including but not limited to unusual driving behavior, unsteady on feet, bloodshot, glassy eyes, odor of unknown alcoholic beverage), I detained Naranjoarambula as if conducting a traffic stop and took possession of Naranjoarambula's driver's license.

OBSERVATION OF DRIVER:

Naranjoarambula was unsteady on his feet. Naranjoarambula had bloodshot, glassy eyes. Naranjoarambula displayed short term memory problems throughout my contact with him.

DRIVER'S STATEMENTS:

Naranjoarambula stated he had consumed 5 beers after work with friends.

Difficulty following stimulus/instructions

WALK & TURN:

Naranjoambula lost his balance in the starting position several times. Naranjoambula missed heel to toe on the first two steps. On the second step, Naranjoambula lost his balance to the right and stepped off the line while using his arms for balance. Naranjoambula missed heel to toe on every remaining step and used his arms for balance throughout the task. Naranjoambula stepped off the line two more times on the first leg. Naranjoambula took an extra step and stopped after turning around while still using his arms for balance. Naranjoambula missed heel to toe on every step on the return leg. Naranjoambula stepped off the line on the fourth and eighth steps.

ONE LEG STAND:

Naranjoambula put his foot down on 1000-4. Naranjoambula picked his foot up and counted 1000-3 and put his foot down. Naranjoambula picked his foot up and started counting at 1000-5 which he said twice, before hopping and putting his foot back down on 1000-6. Naranjoambula stopped and I told him to continue. Naranjoambula counted 3, then 1000-5 before putting his foot down again. Naranjoambula lost his balance backwards and put his foot down again. Naranjoambula complained about the wind, which was moderate but not excessive. Naranjoambula was also swaying visibly during the exercise.

FINGER TO NOSE

L1: Naranjoambula touched his nose to the left of the tip. R2: Naranjoambula touched the tip of his nose with the pad of his finger. L3: Naranjoambula touched the left side of the bridge of his nose, about 2/3 of the way up his nose from the tip. R4: Naranjoambula touched the right side of the bridge of his nose above the tip. R5: Naranjoambula touched the tip of his nose with the pad of his finger. L6: Naranjoambula touched the tip of his nose with the pad of his finger.
