**PROBABLE CAUSE**

On the above date and time I was in service in Palm Beach County, FL. I was traveling northbound on Interstate 95 (State Road 9) north of Lantana Rd. (County Rd. 812) when a BOLO (Be On The Look Out) was dispatched for a silver in color van driving all over the road, unable to maintain a single lane and almost colliding into other vehicles traveling on the roadway northbound on Interstate 95 (State Road 9) north of 45th St. The witness who called in on the silver in color vehicle stayed land line with dispatch providing information on the silver in color vehicles location until a Trooper intercepted. I then advised dispatch that I would be enroute to the BOLO'd vehicle. After several minutes land line with the witness following the silver in color van dispatch was then advised that the silver in color van pulled off to the right paved emergency shoulder just south of Donald Ross Rd. and then began to travel northbound again on Interstate 95 (State Road 9). I then arrived in the area of where the BOLO'd vehicle was said to currently be traveling and advised the witness to activate their emergency hazard lights so I would be able to locate them. After making visual contact with the witness's vehicle I then observed the silver in color van in front of it still driving in a reckless manner and unable to maintain a single lane. I then observed the silver in color vehicle almost collide with another vehicle in the right outside lane in which I then activated my emergency lights and sirens in an attempt to conduct a traffic stop. The silver in color van then pulled off to the right paved emergency shoulder north of Indiantown and south of MM93 (Mile Marker). I then approached the silver in color vehicle on its right passenger side and observed a white male in the driver seat. The white male appeared to be in a confused state of mind looking straight ahead. I then advised the white male driver who I was and the reasoning of the traffic stop. The white male was later identified to be Guy Owen Stewart 12/09/1962. Mr. Stewart was then asked where he was traveling to. Mr. Stewart then advised me that he was going to Jupiter. Mr. Stewart was then asked if he knew where he was now. Mr. Stewart then advised that he was on 95. Mr. Stewart was then asked how much did he have to drink prior to driving. Mr. Stewart then advised me that he had a couple of beers. I could then smell the odor commonly associated with the smell of an unknown alcoholic beverage emitting from his breath as he spoke. I then observed Mr. Stewart's eyes to be red and glossy in color along with several open beer bottles in the vehicle. I then requested Mr. Stewart to remove the keys from the ignition and to step out of the vehicle. Due to not being in a well-lit area, for the safety of the subject and myself, I transported the subject back to the nearest exit which was Indiantown Rd. (State Road 706). We went to the Shell gas station to attempt to conduct the FSTs in the parking lot which was well-lit and safe from vehicular traffic. Upon arrival at the Shell gas station I then advised Mr. Stewart that I would now be requesting for him to perform a series of roadside exercises due to me having reason to believe he was driving under the influence of alcohol based of my observations and what he acknowledged me. Mr. Stewart was not giving me a yes or no answer and continued to talk around my question. I then requested again for Mr. Stewart to perform, with his consent, a series of roadside exercises. Mr. Stewart then advised me that he has seen plenty of videos of where that doesn't end well and advised me that he was not going to perform the exercises I have requested of him to perform. I then advised Mr. Stewart that if he refuses to consent to perform the series of roadside exercises I have requested of him to perform, that based of my observations of his driving patten, physical observations of himself and what he acknowledged me, that I would place him under arrest for driving under the influence. Mr. Stewart was then requested one more time to consent to the roadside exercises and again advised me he would not perform them. (See Roadside Tasks Sheet / Video)

Based on the totality of circumstances, Mr. Stewart was placed under arrest for DUI pursuant to Florida Statute 316.193.1 at 01:10 AM. Mr. Stewart was then searched and placed in the back of my patrol vehicle and transported to the Palm Beach County Jail in which he arrived at 1:45 AM. After the defendants 20 min observation he was then given the opportunity to provide a breath sample in which he refused at 02:07 AM. Mr. Stewart was then placed in a holding cell in which he continuously hit his head against the concrete wall and advised he was suicidal. The Palm Beach County Jail correction deputy's

were then notified and after a 20min response time they advised me that they would not take him in and he was in my custody until my report was completed for them.





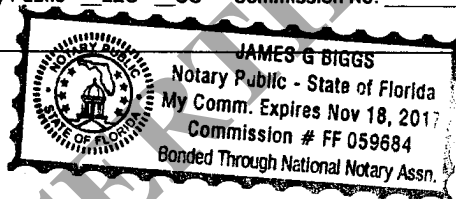
