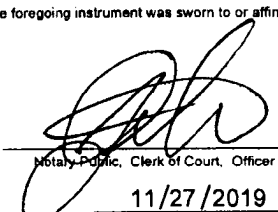

On Wednesday, November 27th, 2019, at approximately 03:33 hours, BBPD Officers were at 1701 Stonehaven Drive, Boynton Beach, Palm Beach County, FL 33436 in reference to a separate incident.

I was leaving the area when I heard loud yelling coming from the 2nd floor of 1701 Stonehaven Drive. Officers proceeded towards the yelling at which time I observed W/F Haley Miller (DOB: 05/04/2000) yelling and arguing with B/F Sonida Derinora (DOB: 03/20/1997) outside in between apartments 6 & 8. Miller's friends were asking to her to go inside and stop yelling but she continued to yell and argue. Officers then instructed Miller to go inside her residence and refrain from yelling at it was early in the morning and neighboring residents were sleeping. Miller refused to go inside and continued to yell profanities at her friends and Officers. Derinora provided a sworn taped statement, captured on Body Worn Camera, attesting to Miller's disruptive behavior.

Based on the above facts and circumstances, I find probable cause to arrest and charge Haley Miller with Disorderly Conduct pursuant to FSS 877.03. Miller was transported to BBPD for processing and later transported and turned over to the care and custody of the Palm Beach County Jail.

It should be noted that this incident was captured on Body Worn Camera.
