

her mother-in-law, Halina Minniti. Dinara said Minniti is living with her husband, Lukasz Kramarz, and they do not normally get along. Dinara moved out of the residence six months ago and only came to visit for Lukasz` birthday. Dinara said she greeted Minniti last when she arrived and Minniti got upset and left the house. Dinara told me that when Minniti returned, she told Dinara to leave the house. Dinara said this was her house too and she would not leave. Dinara told me that Minniti grabbed the front of her shirt and ripped it, and scratched her hand in the process. She called BRPD.


I talked to Minniti who told me that when Dinara came to visit for Lukasz` birthday, she did not receive any attention from her, which made her upset. Minniti said she went to the store to pick up cigarettes, then came back. When she returned, Minniti told Dinara to leave because she does not live there. Minniti told me she grabbed Dinara`s shirt to lead her in the direction of the exit and accidentally ripped Dinara`s shirt.

I spoke with Lukasz who told me he overheard Dinara and Minniti arguing, but did not try to separate them until they were getting loud. Lukasz said Minniti grabbed Dinara`s shirt and ripped it while he was trying to separate them.

I gave Dinara a domestic violence pamphlet and took pictures of the ripped shirt and her scratched finger. Both Dinara and Lukasz completed witness statement forms and Minniti was arrested for Simple Battery/Domestic Violence (784.03(1A1)).
