On the 15 day of MARCH 2018 at 01:00  A.M  P.M (Specifically include facts constituting cause for arrest.)

On March 14, 2018 at approximately 00:58 hours, I responded to the area of 621 Lake Avenue at Brogues in the City of Lake Worth, Palm Beach County, Florida in reference to a fight.

On scene, I spoke with the manager of Brogues who identified herself as Cherylann Keith. Keith advised me the subject who other deputies were speaking to outside who was later identified as Hamdi Kassar was inside Borgues intoxicated and causing a loud disturbance. Keith stated Kassar was yelling, cursing, and refused to leave after she asked him to leave. Keith stated Kassar's erratic behavior was scaring her customers. I also spoke with Brogues bartender Jose Borbely who advised me he observed Kassar in a fight outside and when he tried to intervene Kassar pushed him and swung at him but did not make contact on any of the swings. Borbely also stated that Kassar told him he was going to get his gun to shoot Borbely. Borbely advised that he was in fear due to Kassar's statement.

When I spoke with Kassar, he confirmed that he had been drinking (alcohol) this evening and I smelled a odor of alcohol emitting from his breathe. Kassar was also making irrational statements and not complying with deputies commands. I asked Kassar for his name several times which he refused to provide. Kassar was eventually identified by his identification card. Kassar was placed in handcuffs by other deputies while I was conducting the investigation and later transported to the District 14 substation.

Based on my investigation, Kassar is in violation of F.S.S 856.011, Disorderly Intoxication and F.S.S 843.01, Resist Without Violence.
