On 09/29/2017 at approximately 2239 hours, I responded to the intersection of Boynton Beach Blvd and S. State Road 7, in reference to a motor vehicle crash.

Upon my arrival to the scene of the crash I only observed one vehicle that had heavy rear end damage. I met with the driver Juan Cintra, who stated that he saw an unknown vehicle take off southbound on S State Road 7 from the scene. With the information provided by Juan I drove southbound in my marked PBSO patrol vehicle to see if I could find any vehicles with heavy frontend damage.

While driving south in the 11000 block of S. State Road 7 I located a red Nissan Altima (bearing FL tag GSSQ07) on the side of the roadway. I exited my vehicle and I could see heavy front end damage to the front left of the vehicle. As I was walking up to the vehicle I could see two male juveniles in the rear of the vehicle and a white female in the driver seat. As I opened the driver's door I immediately smelt the presence of an unknown alcohol emanating out of the vehicle. As I spoke with the driver who was later identified by her FL driver's license as Handan Kabba, I could smell the unknown alcohol emanating off of her breath. Handan's eyes were very glassy and she was slurring her words. I remained with Handan until the arrival of Palm Beach County DUI Investigator Scott Levey arrived on scene.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

ON 09/2/2017 AT 2327 HOURS, I RESPONDED TO 11000 BLK SR7 AND BOYNTON BEACH BLVD, JUST SOUTH OF THE INTERSECTION IN REFERENCE TO A TRAFFIC STOP. WHILE ENROUTE TO THE CALL I WAS INFORMED BY DISPATCH AND MOBILE DATE TERMINAL (MDT) THAT A DEPUTY HAD LOCATED A RED NISSAN ALTIMA ON THE SIDE OF THE ROAD.

UPON MY ARRIVAL AT 2315 I OBSERVED THAT THERE WAS A RED NISSAN ALTIMA THAT HAD AN ATTACHED TAG OF GSSQ07, OUT OF FLORIDA. I THEN MADE CONTACT WITH D/S S. CAPOBIANCO #24738, WHO ADVISED ME OF THE FOLLOWING IN A SUPPLEMENTAL PC: "ON 09/29/2017 AT APPROXIMATELY 2239 HOURS, I RESPONDED TO THE INTERSECTION OF BOYNTON BEACH BLVD AND S. STATE ROAD 7, IN REFERENCE TO A MOTOR VEHICLE CRASH. UPON MY ARRIVAL TO THE SCENE OF THE CRASH I ONLY OBSERVED ONE VEHICLE THAT HAD HEAVY REAR END DAMAGE. I MET WITH THE DRIVER JUAN CINTRA, WHO STATED THAT HE SAW AN UNKNOWN VEHICLE TAKE OFF SOUTHBOUND ON S STATE ROAD 7 FROM THE SCENE, WITH THE INFORMATION PROVIDED BY JUAN I DROVE SOUTHBOUND IN MY MARKED PBSO PATROL VEHICLE TO SEE IF I COULD FIND ANY VEHICLES WITH HEAVY FRONT END DAMAGE. WHILE DRIVING SOUTH IN THE 11000 BLOCK OF S. STATE ROAD 7 I LOCATED A RED NISSAN ALTIMA (BEARING FLORIDA TAG GSSQ07) ON THE SOUTH SIDE OF THE ROADWAY. I EXITED MY VEHICLE AND I COULD SEE HEAVY FRONT END DAMAGE TO THE FRONT LEFT OF THE VEHICLE AND A WHITE FEMALE IN THE DRIVER SEAT. AS I OPENED THE DRIVER'S SIDE DOOR, I IMMEDIATELY SMELT THE PRESENCE OF AN UNKNOWN ALCOHOL EMANATING OUT OF THE VEHICLE. AS I SPOKE WITH THE DRIVER WHO WAS IDENTIFIED BY HER FL DRIVER'S LICENSE AS HANDAN KABBA, I COULD SMELL THE UNKNOWN ALCOHOL EMANATING OFF OF HER BREATH. HANDAN'S EYES WERE VERY GLASSY AND SHE WAS SLURRING HER WORDS. I REMAINED ON SCENE WITH HANDAN UNTIL THE ARRIVAL OF PALM BEACH COUNTY DUI INVESTIGATOR SCOTT LEVEY ARRIVED ON SCENE."

OBSERVATION OF DRIVER:

AS I APPROACHED THE DRIVER'S SIDE OF THE VEHICLE, I OSBERVED THAT THE DRIVER WAS SEATED IN THE DRIVERS SEAT OF THE VEHICLE, AND THAT SHE WAS THE ONLY OCCUPANT IN THE VEHICLE AT THE TIME I ARRIVED. I WAS PREVIOUSLY HANDED THE DRIVER'S FLORIDA DRIVER LICENSE. I ASKED HER TO PROVIDE ME HER CURRENT ADERESS IN WHICH SHE WAS UNSURE AND PROVIDED ME WITH 23130 FLORAL RD, BOCA RATON, FL, 33433. SHE PROVIDED ME HER PHONE NUMBER, AND OTHER INFORMATION WAS CONFIRMED. I INFORMED HER THAT I WAS CALLED TO MAKE SURE THAT SHE COULD OPERATE THE VEHICLE SAFELY. SHE STATED THAT HE UNDERSTOOD. WHILE I WAS SPEAKING WITH HANDAN, I NOTICED THAT SHE HAD THE OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM THEIR PERSON, AND AS SHE SPOKE TO ME IT BECAME STRONGER.

DRIVER'S STATEMENTS:

I THEN READ HANDAN MIRANDA FROM THE PREPARED PBSO ISSUE CARD. SHE STATED THAT SHE UNDERSTOOD HER RIGHTS. HANDAN STATED THAT SHE HAD BEEN DRINKING, TWO DRINKS, FOUR HOURS AGO. I NOTICED THAT HER SPEECH WAS SLOW, SLURRED, AND SHORT. I NOTICED THAT HER ATTITUDE WAS CALM, COOPERATIVE, OVERLY FRIENDLY, AND POLITE. I OBSERVED THAT SHE WAS WEARING A RED T-SHIRT, BLACK PANTS, AND WHITE AND PINK SANDALS. I ALSO OBSERVED HER EYES AND THEY WERE GLASSY. I CONFIRMED THAT HANDAN HAD NO MEDICAL CONDITIONS. SHE CONTINUALLY TOLD ME THAT [REDACTED] WAS ON THE WAY AND TO HAVE HIM TAKE [REDACTED] AND HER HOME.

I HAD HANDAN EXIT THE VEHICLE AND WALK TOWARD ME. ONCE I WAS SPEAKING WITH THEM, AWAY FROM THEIR VEHICLE, THE ODOR WAS STILL PREVALENT. I THEN ASKED HANDAN IF THEY WOULD BE WILLING TO DO SOME ROADSIDE TASKS TO MAKE SURE THAT THEY WERE OKAY TO DRIVE. HANDAN STATED THAT SHE WOULD DO ROADSIDE TASKS.

ODORS:

OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM HER PERSON, AND AS SHE SPOKE TO ME IT BECAME STRONGER. ONCE I WAS SPEAKING WITH THEM, AWAY FROM THEIR VEHICLE, THE ODOR WAS STIL PREVALENT. IT SHOULD ALSO BE NOTED THAT ONCE SHE WAS PLACED INTO THE BACKSEAT OF MY PATROL CAR AND I RE-ENTERED IT A SHORT TIME LATER, THERE WAS NOW THE OBVIOUS ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE THAT WAS NOT THERE PREVIOUSLY TO HIM BEING PLACED INTO THE BACKSEAT.



Other Observations:

INV. S. LEVEY #9415 CONDUCTED THIS TASK. THE OVERHEAD FORWARD FACING BLUE POLICE LIGHTS WERE TURNED OFF PRIOR TO BEGINNING THE TASK. THEIR EYES TRACKED EQUALLY. THE PUPILS WERE THE SAME SIZE AND APPROPRIATE FOR THE LIGHTING CONDITIONS, AND NO RESTING NYSTAGMUS WAS OBSERVED. VERTICAL GAZE NYSTAGMUS WAS ADMINISTERED AND WAS NOT OBSERVED. IT SHOULD BE NOTED THAT I HAD TO CONTINUALLY REMIND HANDAN NOT TO MOVE THEIR HEAD, AND TO FOLLOW THE STIMULUS, NOT LOOK PAST IT OR ANTICIPATE IT MOVING.

WALK & TURN:

I EXPLAINED AND DEMONSTRATED THE INSTRUCTIONS FOR THE WALK AND TURN TASK TO HANDAN WHO STATED THAT SHE UNDERSTOOD. DURING THE TASK I OBSERVED THAT HANDAN HAD THE FOLLOWING CUES: STEPPED OFF THE LINE ON MAJORITY OF STEPS AND WALKED WITH EACH OTHER STEP OFF THE LINE.

ONE LEG STAND:

I EXPLAINED AND DEMONSTRATED THE INSTRUCTIONS FOR THE ONE LEG STAND TASK TO HANDAN WHO STATED THAT SHE UNDERSTOOD. PRIOR TO BEGINNING THE TASK, SHE EXITED THE INSTRUCTIONAL STANCE. DURING THE TASK I OBSERVED THAT HANDAN HAD THE FOLLOWING CUES: SHE WAS UNABLE TO STAY IN THE INSTRUCTIONAL STANCE; SWAYED WHILE BALANCING; USED ARMS FOR BALANCE (RAISES ARMS OVER SIX INCHES); POINTS FOOT UPWARD NOT PARALLEL TO THE GROUND. SHE ALSO HAD TO BE REMINDED TO LOOK AT HER FOOT AS SHE CONDUCTED THE TASK.

FINGER TO NOSE:

I EXPLAINED AND DEMONSTRATED THE INSTRUCTIONS FOR THE FINGER TO NOSE TASK TO HANDAN. I EXPLAINED WHAT IS CONSIDERED THE TIP OF THE FINGER AND TIP OF THE NOSE TO HANDAN WHO STATED THAT SHE UNDERSTOOD. 


