On 02/22/2018, at 0951 hours, I arrested Harry Joseph Hutchinson (W/M DOB 05/22/1974) with one count Disorderly Intoxication pursuant to F.S.S. 856.011, one count Possession of Marijuana under 20 grams pursuant to F.S.S. 893.13 (6) (B), and one count Resisting without Violence pursuant to F.S.S. 843.02. On 02/22/2018 at approximately 0933 hours, I was dispatched to the Four Seasons Hotel (2800 South Ocean Blvd) in reference to an intoxicated white male that was exposing his genitalia to hotel guests. Upon my arrival, I met with Head of Security Michael Lacouture and other security team members who were standing outside of room #302. Lacouture stated that Hutchinson exposed himself to guests by the pool. Lacouture goes on to say that, he escorted Hutchinson to his room and while they were walking to his room, Hutchinson stated verbal threats to security members and guests. Hutchinson also exposed himself to another guest in the hallway. When I knocked on the hotel door, Hutchinson opened the door naked. Hutchinson was barely able to stand on his own accord and had extremely slurred speech. His eyes were bloodshot and glassy and he had a very strong odor of an unknown alcoholic beverage that would intensify as he spoke. I advised Hutchinson to put clothes on, and collect his belongings because hotel security wanted him to leave the premises. Ofc. A. Mazza arrived on scene to provide additional assistance. Hutchinson asked me to come into his room while he gathered his belongings. On the TV stand, in plain view, was multiple empty alcohol bottles, marijuana, and Clonazepam. Hutchinson put his clothes on and walked out of the room. Once Hutchinson exited the room and entered the hotel hallway, where hotel security was standing, Hutchinson became very aggressive. He began screaming, "Fuck you! Fuck you and Fuck you!" to the security members.

PROBABLE CAUSE STATEMENT	While screaming profanities, Hutchinson walked towards one of the security members, Officer A. Mazza attempted to place Hutchinson in handcuffs. Hutchinson pulled his arms apart and used his weight to push back into Officer A. Mazza while walking backwards. Hutchinson did this so he would not be placed in handcuffs. Officer. A. Mazza and I escorted Hutchinson to the ground and placed him in handcuffs. The handcuffs were double locked and checked for tightness. As Officer A. Mazza and I walked Hutchinson to my vehicle, he stated that we were "faggot cocksuckers" and continued to scream other profanities. I placed Hutchinson in the rear of my patrol vehicle #804. While I was transporting Hutchinson to Palm Beach Police Dept. for processing, he stated that he hated "homo niggers". Hutchinson also stated that I had to let him out of my patrol vehicle or his family would "ruin my life". Hutchinson was transported to the Palm Beach County without further incident.
