





While performing the task she missed heel to toe numerous times, stumbled off the line, raised her arms for balance, did not turn as instructed and while returning back down the line did not perform the task as instructed just walking normally back still unable to stay on the line.

ONE LEG STAND:

Swayed while in the instructional position. Starting the task she was unable to keep her foot elevated for any duration of time ultimately abandoning the task.

FINGER TO NOSE:

Swayed while in the instructional position. Starting the task she began to move her fingers to her nose on her own. She touched her finger to her nose with both hands three times before I stopped the task and reemphasized that I would provide the commands of left or right. Starting the task again she appropriately touched her finger to her nose however had to be reminded to tilt her head forward.

ROMBERG ALPHABET:

Swayed while in the instructional position. Starting the task she completed the alphabet appropriately however had a distinct slur to her speech.


