On 1/30/17 at approximately 2205 hours I observed a blue Oldsmobile bearing FL tag "HLVE88" driving northbound on Military Trail passing Lake Blvd in Unincorporated Delray Beach within Palm Beach County, Florida. The aforementioned vehicle was driving carelessly failing to maintain a single-lane ; swerving from the #1 to the #3 lane; without stopping in the #2 lane, the Oldsmobile was driving with no regard for the heavy traffic which was present on the roadway, multiple vehicle had to stop in the roadway to keep from colliding with the Oldsmobile. The Oldsmobile also had a large broken passenger side taillight emitting a white light to the rear of the vehicle.

The aforementioned vehicle was missing the front driver side tire and rear driver side tire driving on only the rims, heavy smoke was coming from the vehicle and sparks where observed coming from the vehicle's rims. This caused a severe safety concern for not only the driver but other motorists which were present on the roadway at the time of my observations.

A lawful traffic stop was conducted were I made contact with the driver who later identified herself as Heather Darby. I explained the reason for the stop requiring Darby to provide her drivers license; she stated it was in her purse, Darby was provided her purse but did locate her license, she then stated it was in her car; after looking she could not find it. While speaking with Darby I could smell an obvious odor of an unknown alcoholic beverage emitting from her person. While continuing to speak with Darby I observed her speech was slurred and slow and she was sweating on a rather cool night. Her questions to me became repetitive and she seemed to be confused by me asking her to remain seated which was to ensure her safety, she was unsteady on her feet and I was concerned she may fall. Darby stated her car was in "bad shape" that's why her tires were non existent. She stated she had two beers and was attempting to drive home to Margate, Florida.

Based on my observation I summoned Deputy Schneider ID 8501 to the traffic stop to conduct a DUI investigation concluding my involvement in the matter.

D/S Cook stated: "On 1/30/17 at approximately 2205 hours I observed a blue Oldsmobile bearing FL tag "HLVE88" driving northbound on Military Trail passing Lake Blvd in Unincorporated Delray Beach within Palm Beach County, Florida. The aforementioned vehicle was driving carelessly failing to maintain a single-lane; swerving from the #1 to the #3 lane; without stopping in the #2 lane, the Oldsmobile was driving with no regard for the heavy traffic which was present on the roadway, multiple vehicle's had to stop in the roadway to keep from colliding with the Oldsmobile. Her questions to me became repetitive and she seemed to be confused by me asking her to remain seated which was to ensure her safety, she was unsteady on her feet and I was concerned she may fall. Darby stated her car was in "bad shape" that's why her tires were non-existent. She stated she had two beers and was attempting to drive home to Marcote, Florida."

OBSERVATION OF DRIVER:

I observed Darby to have red bloodshot and glossy eyes. As she spoke to me and while within close proximity I observed the odor of a unknown alcoholic beverage coming from her body and facial area. After asking her to stand I observed she was generally unsteady and swayed while stationary.

DRIVER'S STATEMENTS:

I had a couple beers after work. Asked the repercussions of not doing the sobriety tasks. Taylor warnings were issued.

Distinct and sustained odor of alcoholic beverages.

Other Observations:

Darby had a sway while standing in place. Vertical nystagmus present.

WALK & TURN:

Darby was unable to maintain the resting position and was observed shifting in place while attempting to maintain the instructional position. She ultimately had to be placed in the instructional position for a second time prior to starting the task. Performing the task Darby failed to touch heel to toe on multiple occasions, stepped off the line on step 5, performed a improper turn, and failed to touch heel to toe the opposite direction.

ONE LEG STAND:

Darby swayed while stationary in the instructional position. Beginning the task her left leg shook and she appeared to have difficulty in counting in sequence. She was able to keep her foot elevated for the entire thirty seconds.

FINGER TO NOSE:

Darby swayed while in the instructional position. Beginning the task she had to be prompted to tilt her head back contrary to instruction. The first left command she slowly approached her nose appearing to search for the tip however ultimately touched the left side of her nose. The first right command she opened her eyes and tilted her head forward before having to be verbally corrected. She appeared to sway heavily and had to be repositioned. While raising her right hand she held her finger to her nose and had to be prompted to remove it. The second left she touched the left side of her nose. The second right she performed as instructed. The third right she failed to touch the tip of her finger to her nose. The third left she performed as instructed.






