On the above date and time, W/M Henry Figueroa Carranza was placed under arrest for DUI. While searching his person incident to arrest, 2 small pink bags and 1 clear bag containing a white powdery substance was located. One bag was found in his back right pocket, another in his back left pocket, and the final bag in his front left pocket. Based on my training and experience, I believed the powdered substance was cocaine. D/S Cowart #30556 field tested the substance with a SIRCHIE Cobalt test and yielded positive results for cocaine by turning blue in color. The cocaine was also tested with a Marquis test kit which yielded negative results. D/S Cowart weighed the cocaine which gave a total of 0.5g. The cocaine was properly placed into PBSO evidence by D/S Cowart. Based on the above mentioned facts, probable cause also exists for the arrest of Figueroa Carranza for the following charge: POSSESSION OF COCAINE - FSS 893.13(6)(A)

NARRATIVE:

On Saturday, May 25th, 2019 at approximately 0446 hrs I responded to a possible intoxicated driver complaint at Haverhill Rd/Forest Hill Blvd, in unincorporated West Palm Beach, Palm Beach County, Florida, 33415.

While en route communications advised that the complainant identified as Michau Beaudoin was landline advising that she was following a possible impaired driver traveling east bound on Forest Hill Blvd. Beaudoin advised the vehicle dark colored pick up bearing Florida License Plate DSUY86 was stopped at the intersection of Haverhill Rd and Forest Hill Blvd at this time not moving.

Upon arrival I observed the vehicle a dark color Dodge Ram Pick up bearing Florida License Plate DSUY86 stopped in the south bound left turn lane of Haverhill Rd just north of Forest Hill Blvd. I observed the driver to be a hispanic male, I also observed a black 4 Door Passenger car stopped in the south bound left turn lane behind the pick up truck with it's emergency flashers activated.

I made contact with the driver of the black passenger car who was identified as the complainant Michau Beaudoin. Beaudoin informed me that she had been following the vehicle which had been driving erratically all over the road. Beaudoin advised that the driver of the vehicle was still seated inside of the vehicle.

I then made contact with the driver of the vehicle who verbally identified himself as Henry Joel Figueroa-Carranza. Upon speaking with Figueroa-Carranza I noted his

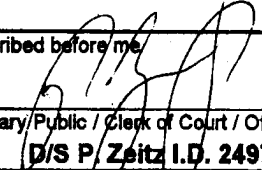
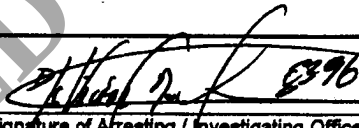

eyes were blood shot red and watery, I observed a strong odor of an unknown alcoholic beverage emanating from his head and shoulder area. I inquired with Figueroa-Carranza as to whether or not he had been drinking tonight to which he advised that he had consumed 4 beers.

Figueroa-Carranza advised that he did not have a drivers license, I inquired with him as to where he was going to which he informed me that he was on his way to work.

At this tim based on my observations of Figueroa-Carranza I believed he was operating a motor vehicle under the influence of alcohol therefore I requested a D.U.I./ Traffic Unit respond to the scene.

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 5/25/2019, I was dispatched to a call of a suspected impaired driver. Upon arrival I spoke to witness Michou Beaudoin who advised me of the following.

Beaudoin stated that she was driving to work when she noticed a green truck swerving in and out of its lane multiple times. She stated that the vehicle almost struck numerous other vehicles. Fearing that the driver was possibly impaired and could cause a crash, she called 911 and provided details about the vehicle.

D/S Blackman made contact with the vehicle on Haverhill Rd just North of Forest Hill Blvd. He identified the driver of the vehicle as W/M Henry Figueroa Carranza. He noticed articulable indicators of impairment and called for a DUI investigator to respond to the scene. He provided a sworn supplemental probable cause affidavit detailing his findings.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by his Honduras passport as Henry Figueroa Carranza, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from his person and breath. This odor intensified as I spoke to him. He had glassy, glazed, and blood shot eyes. Figueroa's speech was slurred, slow, thick, and at times difficult to understand. His movements were slow and deliberate, and lethargic with poor coordination. He had an unsteady gait while walking to my patrol vehicle and had difficulty following directions given to him. He was wearing a white shirt with blue shorts and brown sandals.

DRIVER'S STATEMENTS:

Pre-Miranda: Told D.S Blackman that he had four (4) beers but told me later that he had nothing to drink.

Refused breath samples and Q&A not conducted.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from his person and breath which intensified as I spoke to him.

GENERAL OBSERVATIONS

SPEECH: Figueroa's speech was slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: Emotional and belligerent

CLOTHING: White shirt with blue shorts and brown sandals

MEDICAL/OTHER: Knee problems

Other Observations:

Figueroa would sway roughly in a side to side front to back pattern throughout the task. He was reminded numerous times to track the pen with his eyes only. He failed to keep his head still while tracking the stimulus. Figueroa would continually and intentionally look away from the stimulus. I was unable to finish the Pen/Light task.

WALK & TURN:

Utilizing Palm Springs Officer Ferrer for interpretation, I explained and demonstrated the instructions for the "Walk & Turn" to Figueroa who stated the he understood. During the task, I observed him to sway roughly in a side to side, front to back pattern throughout the demonstration phase. He could not maintain his balance while listening to instructions. He stepped out of the instructional stance during the demonstration to catch his balance. Figueroa started the task before being instructed to do so. He would stop walking to steady himself. He missed heel-to-toe steps and stepped off the line. He used his arms for balance by raising them more than six inches. He also performed an improper turn and took 10 steps on both the first and return steps.

After doing this exercise, Figueroa began complaining that his knee hurt and he could not do the one leg stand task. The seated battery was started at that time.

FINGER TO NOSE:

Utilizing Palm Springs Officer Ferrer for interpretation, I explained and demonstrated the instructions for the "Finger to Nose" task to who stated that he understood. During the task, I observed him to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Figueroa's index finger did not touch the tip of the nose on 5 of 6 attempts. he searched for the tip of his nose using the finger to find their nose prior to touching the tip. The sequence used for this task was L, R, L, R, R, L.

PALM PAT:

Utilizing Palm Springs officer Ferrer #159, I explained and demonstrated the instructions for the "Palm Pat" task to Figueroa who stated the he understood. The defendant failed to maintain the instructional stance. After beginning the task, he rolled his hands (kept edge of one hand on the other when turning), double patted, chopped, and failed to increase speed as instructed.

HAND COORDINATION:

Utilizing Palm Springs officer Ferrer #159, I explained and demonstrated the instructions for the "Hand Coordination" task to who stated the he understood. The defendant failed to maintain the instructional stance, started before being told, and or "copied me." After beginning the task and during the forward steps, he improperly touched. During the return steps, the defendant improperly touched.

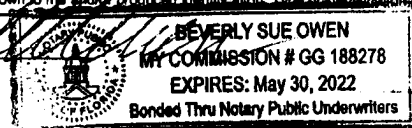
