On 04/28/2018 at 2316 hours, I was dispatched to 6541 Sleepy Willow Way, within unincorporated Delray Beach, Florida, in reference to a domestic disturbance.

Upon arrival, I made contact with the husband who verbally identified himself Henry Garberg. Henry stated that that he and his wife who was later identified by Florida ID card as Tylisha Tracy, were in a verbal argument that escalated into a physical altercation after she punched him on his head several times. He said that Tylisha became very jealous about a message that he received on a social media website and because they both drank Tequila earlier in the night, it made the situation worse. He then said that he punched her back on her face several times. He said he knew that he shouldn't have struck her because he was a lot stronger than her but he was very angry. Henry had a minor scratch on his forehead that he said he received from her ring when she punched him.

Deputy J. Stewart then spoke to Tylisha, who was in the spare bedroom and who was crying hysterically, and bleeding from her nose and mouth. She had a swollen cheek that was red in color, and bloody clothes from the injuries to her nose and mouth. Tylisha stated that they had been arguing for many hours and that because he was heavily intoxicated, he started to push her with his elbows on her shoulders. She tried to leave the area that he was in to avoid a fight but he followed her into the spare bedroom where Henry used his elbow to strike her face. She said that he hit her multiple times but she was unsure how many. She stated that she never hit him back because she was afraid of what he might have done.

Henry's sixteen year old son Zachary was at the residence at the time of the incident but he advised that he did not hear what the argument was about or see the physical altercation.

Based on my investigation, I determined that Henry Garberg was in violation of F.S.S 784.03(1)(A)(1) Battery-Domestic related because he did actually and intentionally touch and strike his wife Tylisha Tracy, against her will with his elbow across her face.
