Holly stated she got into a verbal argument tonight with her Fiancé, Kevin Molidor W/M 9-1-1984. During the argument, Holly admitted she knocked over the patio table, but it did not strike Kevin. She said she was kicked out of the residence by Kevin, he then locked her out and would not let her back inside. Holly said there was no physical altercation as it was only verbal. While speaking to Holly, she appeared visibly upset as she was crying and unable to control the volume of her voice. It was obvious she had been drinking an alcoholic beverage as I could smell the odor emanating from her person, which got stringer the more she spoke.

I then made contact with Kevin, he appeared calm. He stated, he picked up Holly from a friend's home in Port St. Lucie where she was drinking. When they both returned home, they were sitting on the outside patic and he said something she did not like, he would not elaborate on what he said. Holly then flipped over the patic table and grabbed Kevin by his sweater around his neck. Kevin said, Holly then began to flail and punch him on his back. Kevin began to leave the home, but then at the door way, Holly shoved him into the corner near the inside of the door. As Kevin attempted to finally leave the residence, he said Holly punched him in the back of the head multiple times. Once Kevin was outside, Holly exited the home. He was able to reenter the home and lock Holly outside. Kevin advised me, he and Holly have been in a relationship for 18 years, and have two children together as well as live together. I did not observe obvious marks or bruises on the back of Kevin's head. I took photos of Kevin and the area where he stated Holly struck him with my department issued evidence.com cellphone. Kevin completed a sworn statement via my BWC.

I then spoke with Colin Molidor W/M 1-18-2010. Colin is the son of Holly and Kevin. Colin told me he heard his parents arguing. He then saw his mother shove his dad into the corner near the door. As his dad left the residence, he saw his mother punch him in the back.

I then spoke with Brooke Molidor W/F 6-9-2005. Brooke is the daughter of Holly and Kevin. Brooke told me she was in her room and heard her parents arguing, but did not witness the altercation.

Holly was placed under arrest for domestic simple battery and advised of same. She was handcuffed, which were checked for tightness and double locked. Officer Anderson assisted with a pat down of Holly. I transported Holly to the PBC Jail without incident. Prior to being placed into handcuffs, Holly made no mention of being battered, after she was placed under arrest, she began to get upset and stated Kevin battered her.
