On April 14, 2017 at approximately 2140 hours I was dispatched to 619 S L St in the City Of Lake Worth FL, Palm Beach County FL in reference to a domestic battery. Upon my arrival I met with the victim Howard Lanchenauer who stated his daughter Hope Lanchenauer stroke him and scratched him on the left side of his neck. I observed three scratch marks along his left side of the neck which match his description of his injuries.

Howard stated that Hope had been drinking for an unknown amount of time, and is extremely intoxicated. Howard advised Hope started arguing because she wanted more money from him. Howard explained that she temporarily works for him and had already given her money. Hope started pushing Howard around leaving scratch marks on his left side of his neck.

I spoke to Hope and she stated that they both got in an argument and started pushing each other around. There were no visual sign of injury on Hope. Hope was extremely intoxicated and had slurred speech. Hope was handcuffed, checked for proper tightness, and double locked. She was placed in the back of my marked PBSO patrol Vehicle and transported to the Palm Beach County Jail and Booked.

Due to the above facts Hope Lanchenauer was charged and arrested for actually and intentionally touch or strike Howard under F.S.S 784.03(1).
