PROBABLE CAUSE

On 09/08/19 at approximately 0315 hours Officer K. Lopez and Detective R. Cook conducted a traffic stop for failure to use traffic signal when switching lanes with heavy traffic present and for an equipment violation on a blue 2004 Jeep bearing TAG KPFF70. Said traffic stop was conducted at 105 N. US Highway 1 within the Village of Tequesta.

Officer R. Cook made contact with the driver Robin Jackson and I made contact with the front passenger Hunter G Hurley. A strong odor of Marijuana was coming from the vehicle the all occupants were required to exit to investigate further. (PA vs Mimms & MA vs Wilson) All three were asked if they had a Medical Marijuana card, they stated no. All three were asked if they had any hemp, they stated no. All three consented to pat down of their person.

Hurley was asked if there was anything illegal substance or weapons on his person he said no. When asked to search his person he said yes. While searching him there was a cigarette packet in Hurley's right cargo pocket. He was asked what was in it and he immediately stated he had cocaine in the cigarette pack. Hurley was taken into custody placed in handcuffs which were checked for spacing and double locked. Hurley then stated he wanted to save us the trouble and stated he had another bag of cocaine in his pocket.

The suspected cocaine was tested using a Sirchie NARK test kit specifically for cocaine. Once the suspected cocaine was applied the test kit it turned blue revealing said white powder is in fact positive for cocaine. There was a total of 1.4 grams of cocaine.

Hurley was read his Miranda rights; Hurley stated he understood his rights and began to speak with me without hesitation. Hurley stated all the cocaine belonged to him for personal use. Hurley stated he intended on using the cocaine while drinking and watching football tonight. Hurley stated both bags of cocaine were in the car door; once he knew they were getting pulled over he concealed both bags on his person.

At the conclusion of mu investigation with the information provided I have probable cause to arrest Hunter G Hurley (04/05/1994) for one count of possession of cocaine FSS 893.13.6a; see completed report for further detail.
