PROBABLE CAUSE	On 12/12/19 at approximately 0205 hours, I responded to O'Brians Irish Pub (51 SE 1st Ave) reference a fight that just occurred. Upon arrival, I met with the bouncer/victim at O'Brians Delroy Thompson.								
	Thompson advised throughout the night an individual, who he knew as a frequent patron at the bar, continuously caused problems with staff members and guests. He said the individual (later identified via FL DL as Hussein Abla) was intoxicated and at 0200 hours, when the bar was closed, he refused to leave. Thompson said Abla stood in the front doorway with a drink in his hand and refused to exit the bar. After asking Abla to move multiple times, Thompson said Abla turned toward him and threw the drink in his face. Thompson stated Abla then tried to hit him with the bottle he was holding but was unsuccessful. Thompson explained when Abla tried to hit him with the bottle, he grabbed his left wrist with his right hand, and punched Abla above his right eyebrow with his left hand. Thompson said he then pushed Abla out the front door and placed Abla in a "choke hold" until other employees of the bar told him to go inside. Thompson advised he then went inside and waited until police showed up.								
STATEMENT	I spoke with a witness, Paul Kilkenny, who explained the same events as Thompson. Kilkenny said he was DJing for O'brians and at closing time, .0200 hours, after being asked to leave the bar multiple times, Abla stood in the doorway and would not exit. Kilkenny said Abla then turned and threw his drink in Thompson's face. He said Thompson pushed Abla outside and he could no longer see what was happening.								
	I talked to Abla who stated he was unsure why the altercation took place. He said he did not remember blocking the doorway nor did he remember throwing the drink in Thompson's face.
