PROBABLE CAUSE

On November 5, 2016 at approximately 3:25PM, I was in service in Palm Beach County. I was stationary on the right shoulder of the Florida Turnpike (SR-91) just north of SR-808 (Boynton Beach Blvd.) I was observing traffic traveling southbound. I observed a white vehicle in the inside lane traveling at a high rate of speed, I estimated the speed at 95 MPH. I activated my laser and received a speed of 94 MPH in a 65 mph zone. I initiated a traffic stop on the right paved shoulder. I approached the driver, identified myself as Trooper Thompson of the Florida Highway Patrol and asked the driver for her driver's license, insurance and the registration for the vehicle. Upon contact with the vehicle I observed there to be an odor of an unknown alcoholic beverage coming from the interior of the vehicle and the driver to having glassy eyes. The driver handed me her California Identification Card number (F3466421) and vehicle registration. I informed Ms. Condurache that she was stopped for traveling 94 mph in a 65 mph zone. I went back to my patrol vehicle to check the vehicle's registration tag number AYWB30. The vehicle came back registered to a JOANNA FOX at 1299 S OCEAN BLVD APT K6 BOCA RATON, FL 33432. I conducted a check to see if Ms. Condurache had a Florida driver's license and it came back to Irina Condurache (C-536-400-84-747-0) of 655 S HOPE ST UNIT 802 LOS ANGELES, CA. 90017 as being LICENSE NOT VALID. I observed Ms. Condurache exited her car and attempted to leaning against her car. I advised Ms. Condurache to get back in her car. I asked her for her car keys and advised her to stay in the vehicle. I observed her becoming upset and I approached her car and asked her to exit the vehicle. I advised her that she was not under arrest but for her safety she was going to be handcuffed and detained in the rear of my patrol vehicle. Mr. Condurache was placed in the rear of my patrol car with her hands handcuffed behind her back. As she was sitting in the rear of my vehicle she managed to move her hand out from behind her to the front. I call Lake Worth Regional Communication Center (LWRCC) and asked then to run a background check on Ms. Condurache and to forward that information to me. I contacted 1797 (Trooper Derissier) to meet me at my location to conduct a pat down of Ms. Condurache. When Trooper Derissier arrived we relocated just north of our location to area in which I could conduct road side exercises. Ms. Condurache was removed from the back of my patrol vehicle. I advised the driver of my observation of an odor of an unknown alcoholic beverage coming from her breath and that we were stopping her to conduct road side exercises to determine if she was able to driver home. I asked Ms. Condurache if she had any medical condition that would prevent her from conducting these exercises and she stated she did not. I again asked Ms. Condurache if she would be willing to perform roadside exercises to check for impairment and the driver advised that stated she would. I advised the driver that she could remove her heels if she wanted to. Ms. Condurache removed her heels.

Horizontal Gaze Nystagmus-

- Left eye- lack of smooth pursuit
- Right eye- lack of smooth pursuit
- Left eye- distinct and sustained nystagmus at maximum deviation
- Right eye- distinct and sustained nystagmus at maximum deviation
- Left eye- onset of nystagmus prior to 45 degrees
- Right eye- onset of nystagmus prior to 45 degrees

I observed Ms. Condurache to have glassy eyes and an odor of an unknown alcoholic beverage coming from him mouth area and breath. I observed Ms. Condurache to sway during task. Ms. Condurache on two occasions moved his head to the right during this exercise.

Walk and Turn

- Ms. Condurache could not keep balance in the starting position, move her arms around. She started the task before told to do so. Ms. Condurache started the exercise and on all 9 steps she did not perform heel to toe. At the ninth step instead of pivoting on her foot she started to walk backwards. I advised her she need to turnaround and continue walking. On the walk back, again on all 9 steps she did not touch heel to toe.

One Leg Stand-

- Ms. Condurache again was advised to maintain the starting position with her heel and toes together and to keep her arms to her side. Ms. Condurache was advised to begin the exercise. Ms. Condurache raised her right foot and began to count one, two three and so on. Ms. Condurache lost her balance and began to fall. The exercise was terminated for the safety of Ms. Condurache. At approximately 4:25 pm Ms. Condurache was escorted the side of my patrol car and advised that she was under arrest for Driving Under the Influence. Ms. Condurache became resistive and began pulling away from me. Ms. Condurache was advised not to resist or she will be charged with assault on a law enforcement officer. Ms. Condurache was placed in the back of my patrol car with her hands cuffed behind her and seatbelt on. LWRCC was advised that Ms. Condurache was under arrest and that I was transporting her to Palm Beach County Corrections. During the ride to the county jail Ms. Condurache banged her head against the back of the patrol car cage. Ms. Condurache was observed at the Jail as to have no visible signs of injuries to her head or face. Ms. Condurache refused any questioning and refused to submit to a breath test. Ms. Condurache was advised of her constitutional warnings and she advised she understood. The driver refused any questioning. The driver was then taken to booking for processing. * Video is available of road side exercises.

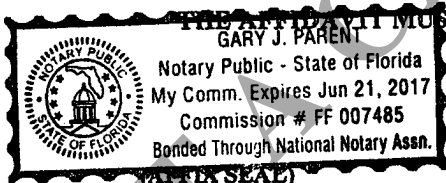



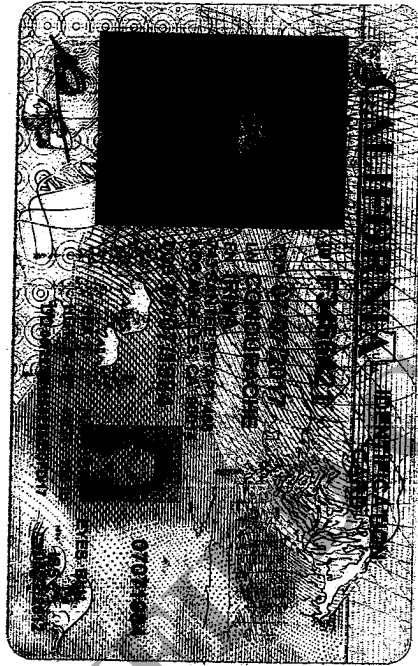
