On the **4th** day of **February** 20 **18** at **0230** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On 02/03/2018 at approximately 2235 hours, I was dispatched to 19365 South State Road 7 in unincorporated Boca Raton, FL in reference to a battery.

Upon my arrival I met with the complainant/ victim, identified by Florida DL as, Jasmine Winns. The victim explained that yesterday (02/02/2018) she was involved in a verbal argument with several persons. During that encounter one of the persons stated "wait till you see my daughter tomorrow bitch." The victim advised that she was wearing her uniform shirt showing she worked at Davito's Italian Restaurant. On 02/03/2018 at approximately 2225 hours the victim stated she was leaving work at Davito's when she observed a juvenile male, later identified by parents as Logan Lezama and a female, later identified by Florida ID Card as, Isabella Lezama in the parking lot of the business parked 4 cars away from where she parked. Upon observing the suspects the victim began yelling at the male. The suspects than rushed the victim striking her numerous time in the body and face. The victim was pushed to the ground and as a result of this the victim suffered a laceration to the top of her head.

I spoke with three witnesses to the battery. All three witnesses explained they did not see how the altercation began, but upon observing the victim in a fight they rushed outside to help the victim. All three witnesses advised they observed both suspects strike the victim even after the witnesses attempted to stop the altercation. All three witnesses positively identified both suspects once they returned to the scene. One witness advised they heard the male suspect state "this is what you get for fucking with my mom."

The female suspect advised she went to the restaurant to order pizza because she and her brother were hungry but they didn't want to spend the money for a pizza at Cumberland Farm. Upon observing the victim she began to yell at her and they "got into it." The suspect stated he was not sure who throw the first punch. The suspect only had a small bruise to her right knee. When asked why she was in the same parking lot as the persons her family was involved in a verbal argument the night before the suspect could not provide a reason.

The male suspect advised they were getting pizza when he observed the same female (the victim) from the previous encounter walking in the parking lot. The male suspect advised that he alerted the female suspect and they confronted her. The male suspect stated he only was defending his sister. When asked why they were in the parking lot of the closed business they could not provide a reasonable response.

The victim was released from the hospital and returned to the scene. The victim positively identified both suspects from a show-up conducted at the scene. The victim advised the laceration on her head required two staples to close the wound.

Based upon the victim and three witnesses identifying the suspects did actually and intentionally touch and strike against the will of the victim and did cause bodily harm to victim, contrary to Florida Statute 784.03(1).
