On the 13 day of March 20 18 at 1230 AM PM

On 3-13-18 at approximately 1230 hours I was on pre-warrant surveillance at 21 Sioux Ct in Lantana when I saw a black Acura driven by a white female who was later identified as Pearson pull into the driveway. She got out of her car and walked into the front door of the house. Within 30 seconds, Pearson exited the house with what appeared to be a plastic bag that contained marijuana. I saw Almendares walk out of the house with a black and chrome box and put it in the Mazda that was occupied by a female who was later identified as Morales. Almendares locked the front door of the house. Pearson left the area followed by Almendares and Morales in a Mazda. Both cars were stopped several blocks away. There was a strong odor of marijuana coming from both cars. Pearson was found to still be in possession of the bag of marijuana that I saw her walk out of the house with. This was tested by Agent Bango and had a positive reaction indicating that this was marijuana. The weight of the marijuana was 29.1 grams.

Based on this I found there to be probable casue for the arrest of Pearson for the carge of possession of marijuana over 20 grams pursuant to Florida State Statute 893.13 (6A)
