I spoke with w/f victim [REDACTED] who corroborated Woodson's statement. [REDACTED] stated she only leaned into Bauman's vehicle to tell him to pick up there [REDACTED] from work. [REDACTED] told me that Bauman started to attack her by grabbing her arm and shaking her. [REDACTED] told me that Bauman then started to strike her in the face with an closed fist. She stated she defended herself by punching Bauman multiple times in the face. She stated that she and Bauman then separated and called 911. [REDACTED] refused to fill out a sworn written statement nor did she wish to fill out any supporting documentation.

I then met with w/f witness Natalie R Woodson (03/04/1998) who advised me of the following:

Woodson stated she was outside in the car port of the home and observed w/m Jack E Bauman (07/29/1972) and [REDACTED] (04/09/1973) engaged in a verbal argument. Woodson told me that the argument originated over Bauman leaving the home to pick up his current girlfriend. Woodson advised me that [REDACTED] started to yell at Bauman and opened the door to his vehicle. The vehicle is described as a 2015 White Nissan Altima bearing Florida license plate: DFCV26.

Woodson advised [REDACTED] leaned into the vehicle and began to yell hysterically at Bauman. She advised that Bauman then grabbed [REDACTED] by her right arm and began to punch [REDACTED] in the face. Woodson told me that she observed Bauman continually jerk [REDACTED] right arm back and forth (Pulling her to and from his body). Woodson stated that [REDACTED] and Bauman then separated and called 911. Woodson then filled out a sworn written statement in relation to her story of events.

I made contact with w/m Bauman who advised he was in his vehicle (Noted above) and was backing out of the driveway. Bauman stated he observed [REDACTED] approach him from his passenger side and started to yell at him uncontrollably. Bauman advised me that [REDACTED] then opened his passenger side door and leaned into the vehicle and continued to scream and verbally abuse him. Bauman stated he then grabbed [REDACTED] by the arm and attempted to push her out of the vehicle when she started to hit him. Bauman advised he only grabbed [REDACTED] by the arm to push her away from his vehicle. Bauman advised his six year old son was in the back seat while the two argued.

I then met with w/m juvenile [REDACTED] told me that [REDACTED] were arguing and that his [REDACTED] (Bauman) grabbed his [REDACTED] and began shaking her. [REDACTED] explained to me that Bauman and [REDACTED] were verbally arguing the entire duration of the incident. [REDACTED] stated while Bauman shook [REDACTED] (Pulling her to and from his body), he observed Bauman start to hit her in the face multiple times with a closed fist. [REDACTED] stated that [REDACTED] then began to punch Bauman. [REDACTED] observed [REDACTED] hit Bauman back several times before the two separated and called 911. [REDACTED] stated he wasn't touched nor was he harmed during the duration of the incident.

I was able to determined that Bauman was the primary aggressor in the altercation.

I then arrested Bauman, placed him into handcuffs and placed him in the back of marked patrol car. I transported Bauman to the Lantana Police station for processing. I later transported and lodged Bauman into the Palm Beach County Jail.

No further information at this time.



