HGN -Once positioned in the front of my vehicle, I continued my investigation. I instructed Deal to keep his hands by his side, stand with his feet together, and follow a pen stimulus with his eyes not turning his head. I asked him if he understood my instructions. Deal verbally stated he understood my instructions. I observed both eyes to be red, bloodshot, and glossy. His left and right eye displayed equal pupil size, equal tracking, and a lack of smooth pursuit. I observed distinct and sustained nystagmus was present in both his left and right eye at maximum deviation during two separate four second evaluations. The onset of nystagmus was prior to a 45 degree angle in both his left and right eye during two separate four second evaluations. While conducting the task I had to remind him to not turn his head and follow the stimulus multiple times.

ONE LEG STAND - I placed Deal with his feet together and arms at his side. I demonstrated the task as I verbally instructed him to raise one of his feet approximately six inches off of the ground, point his toe towards my patrol car, look at the raised foot, and count out loud 1001, 1002, 1003 and so on until told to stop. I asked him if he understood the instructions and demonstration I provided. After Deal stated he understood my instructions, the task was performed. While Deal stood in the instructional position, I observed he started too soon AND swayed while standing stationary. While raising his foot he placed his foot on the ground three times but never completed the task.

FINGER TO NOSE -I instructed Deal to stand with his feet together, make each hand into a fist keeping, extended his index fingers and to place his palms facing up. He was instructed to lower his arms by his side. I instructed and demonstrated the proper hand and arm position and for him to remain in this position while I demonstrated the rest of the task. I instructed and demonstrated to him to tilt his head back approximately 45 degrees and close his eyes while waiting for a verbal command of left or right. On the command of "left" or "right", he would raise the requested hand, touch the tip of his finger to the tip of his nose, then bring his hand immediately back down to his side. I asked him if he understood the instructions I provided and he verbally stated he understood. I instructed him to start the task as explained. During the task, I observed Deal failed to return arms to side, correct finger did not touch tip of nose on one command and he swayed while completing task.





DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Saturday, February 3, 2018 at approximately 05:16 hours, I responded as a back up unit to a call of a person passed out in their vehicle at an intersection. Upon my arrival, I activated my emergency lights behind the vehicle to secure a safe area to check on the driver of the vehicle. I observed the subject asleep in the driver's seat with the vehicle's transmission in DRIVE and his foot on the brake. The driver was the sole occupant of the vehicle. After repeated attempts to wake him up, the subject awoke and seemed disoriented and slow to respond to my verbal commands. Many attempts were made to get him to roll down his driver's side window to which he finally complied. I was able to convince him put the vehicle in PARK and turn the vehicle off. After he opened the door to exit the vehicle, I noticed an odor of an unknown alcoholic beverage coming from the subject. I asked the subject if he was ok to which he replied "I'm just really tired". The subject was asked if he had anything to drink and he stated he had 1 beer. Once we determined that the subject didn't have any medical reasons for falling asleep while driving, I proceeded to conduct a DUI investigation.

OBSERVATION OF DRIVER:

I observed the driver exit from his vehicle and was wearing a green short sleeve shirt, blue jean pants and black athletic shoes. The driver was identified as Jack Eugene Deal by his Florida ID Card and South Carolina Driver's License. I observed Deal's eyes appeared red and glassy. I observed that he was slurring his words and was emitting a strong odor of an unknown alcoholic beverage from his breath. Deal was asked to perform field sobriety tasks which he agreed to.

DRIVER'S STATEMENTS:

I asked Deal if he had been drinking or used any drugs and he stated that he drank a 1 beer but had not used any drugs. I asked Deal if he has any medical problems and/or previous injuries and he answered that he had a 10% disability from the Marine Corps. I asked Deal if he wears glasses or contacts to correct his vision and he answered "no". Finally I asked if Deal was on any medications and he said no.

WALK & TURN:

I positioned Deal on a painted white line which was on a smooth and level surface, free of any debris and well lit by the headlights on my vehicle and nearby street lighting. I instructed the driver to place his left foot on the line and his right foot in front of the left touching heel to toe. I instructed him that he was to keep his hands at his side and stay in this position until I instructed him to do otherwise. I instructed him to walk nine heel to toe steps counting out loud, while watching his feet. On the ninth step he was to keep his front foot on the line and use his back foot, in a series of small steps, to turn around before walking nine heel to toe steps the opposite direction counting out loud and watching his feet. I demonstrated the task while I was verbally instructing him in the proper way to complete the task. During the task, I observed the driver swayed while balancing and could not maintain the instructed position, did not touch heel to toe, stepped off the line once and took incorrect number of steps. Deal uses his arms for balance and did not turn properly. turned wrong direction.




