<p>On Saturday, March 29, 2017, the PBSO D- 14 and 16 Street Crimes Teams conducted an undercover operation within the City of Lake Worth to combat Street Prostitution. Female Deputy Sheriffs posed as prostitutes in specific locations due to citizen's complaints.</p> <p><b>[REDACTED]</b> was one of the 'decoys' posing as a prostitute in the <b>[REDACTED]</b></p> <p><b>[REDACTED]</b> was approached by a W/M in the Burger King parking lot located at 231 N. Dixie Hwy who was later identified as Jacob S. BEARDSLEY herein referred to as the Defendant, who was driving a Blue Ford 4 door bearing FL Tag: DXHB62.</p> <p>Upon BEARDSLEY's contact with <b>[REDACTED]</b> when he drove up to her in the Burger King parking lot, <b>[REDACTED]</b> asked BEARDSLEY if he wanted to have some fun. BEARDSLEY said "sure". She asked if he had cash on him and he said he had \$40.00. <b>[REDACTED]</b> asked what he wanted, and if it was "everything" to include anal that was extra. BEARDSLEY stated that anal wasn't necessary then asked if she had protection for sex. <b>[REDACTED]</b> said yes and directed him to the west portion of the Burger King plaza.</p> <p>The predetermined signal was given and the arrest team responded from a concealed location. I, <b>[REDACTED]</b> stopped the Defendant and took him into custody without incident. The Defendant was placed in zip cuffs that were checked for fit and was transported to PBSO D-14, <b>[REDACTED]</b> where he was processed and later transported to the Palm Beach County Jail.</p> <p>The Defendant requested his vehicle be parked at the Burger King located at 231 N. Dixie Highway Lake Worth FL. <b>[REDACTED]</b> of the transaction was captured by <b>[REDACTED]</b> who were conducting <b>[REDACTED]</b> from a concealed location. The <b>[REDACTED]</b> of the transaction was packaged and entered into evidence at the D-14 Sub Station by <b>[REDACTED]</b></p> <p>Based on the above facts listed above BEARDSLEY was arrested for SOLICITING ANOTHER TO COMMIT PROSTITUTION per F.S.S 796.07 (2) (F). <b>4A</b></p>
